Message from the Marshal



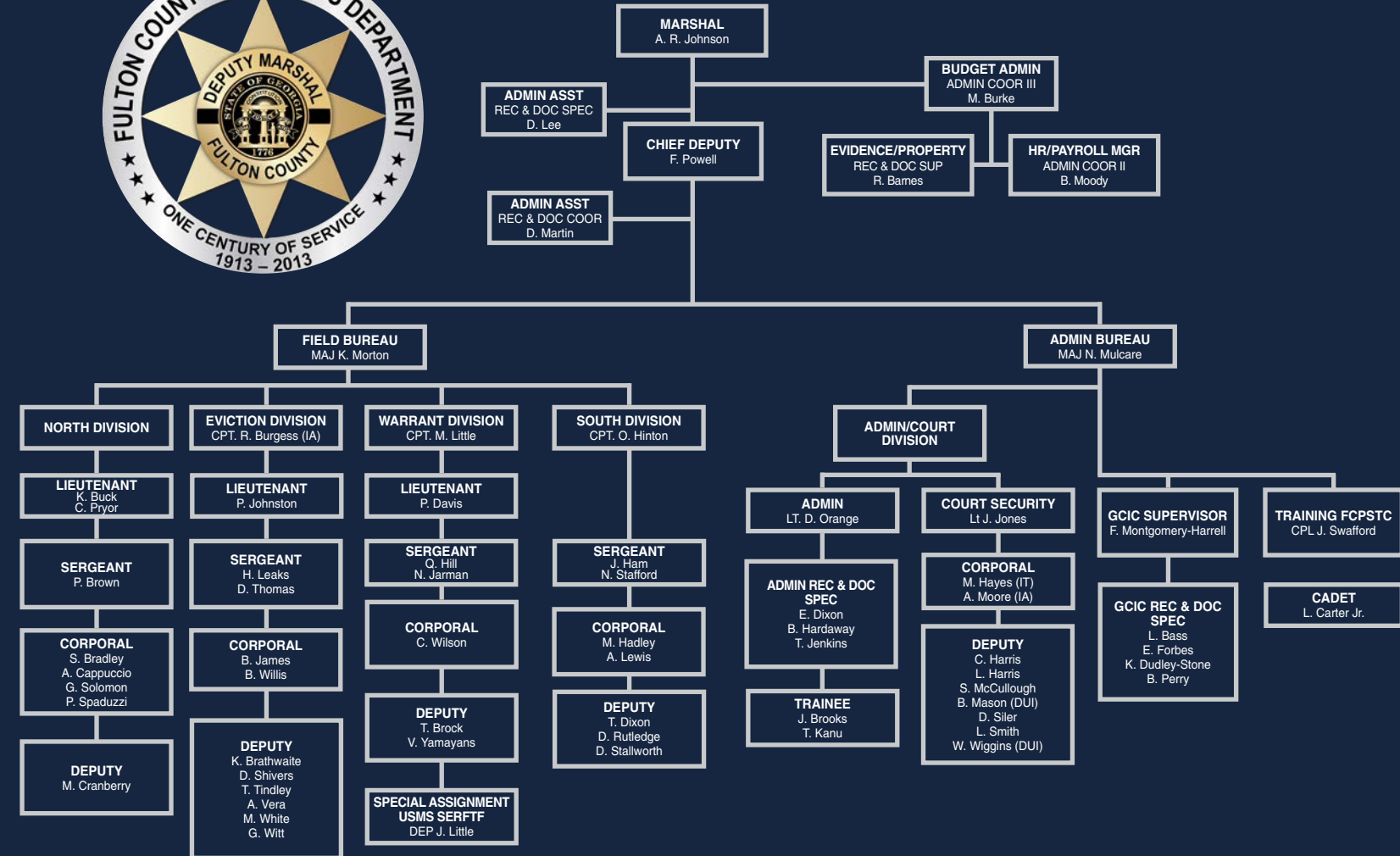
Troops,

CPD8873- Creating tokens in Law Enforcement

- Tokens for Current Date, Officer Badge Number, Officer Title, Login Name, Service District, All plaintiffs, and All defendants.
- Party Name and Party Address tokens will be updated.

CPD9205- Add Party name on the barcode label.

CPD9206- Civil paper status code update

- The civil paper status code table will be updated to now allow the “Sent back to Court” checkbox to be checked on a status with a base status of “Return Unserved”. This will allow the “Sent back to Court” date and time in Case Manager to be automatically updated when a civil paper status is set to a base status of “Return Unserved”.

GIS-Marshal’s Department Routing Project-

This project will allow the routing of civil and criminal papers via Odyssey to achieve the following:

- Electronic and printable media routing directions
- Reduction in fuel and travel related maintenance costs
- Improved customer service
- Interfacing between Odyssey list manager and routing software
- Use of address validation in Odyssey for data source
- Interface with GIS pictures or Pictometry to visually verify curtilage
- Increase productivity
- Reduce time looking at map books

It has been a very exciting year in training for the Fulton County Marshal's Department. We started off the year with our sessions of annual in-service training, which ended with Command Staff training. The Command Staff also participated in a retreat which focused on leadership and morale skill building. Deputies attended training at both the Fulton County Public Safety Training Center and the Georgia Public Safety Training Center.

Training ranged from Field Training Officer, Criminal Procedures, Interviews and Interrogations, Shotgun Skills, and Health and Wellness. Because protection of our judges is our main priority, Sergeant H. Leaks and Corporal A. Cappuccio attended Protective Details "Dignitary Protection" at the Georgia Public Safety Training Center. This training focused on protective escort techniques for dignitaries.

While executing an eviction, Deputy White and Corporal James entered an apartment with the intention of evicting the tenant. The situation turned instantaneously from serving a civil eviction order to a matter of life and death. Upon entrance, they saw the tenant reach for a loaded gun, without thought of their safety; they immediately tackled the tenant and wrestled him for control of the gun. While taking control of the gun, the tenant tried several attempts to point the gun under his chin towards his head. During the struggle, the deputies were able to keep their composure while providing

the tenant encouraging words that his current situation was not worth taking his life. Thankfully, the deputies were able to persuade the tenant to put the gun down. Once the deputies safely restrained the tenant, they located an array of military type weapons and ammunition within the apartment. Although the deputies were in their right to arrest the tenant, they used their compassion to seek professional help for the tenant. As of date, the tenant is successfully recovering and continues to thank Deputy White and Corporal James for saving his life.

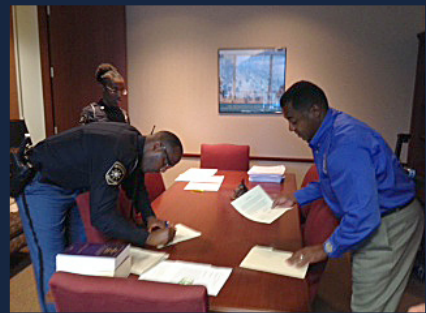

Flag Dedication

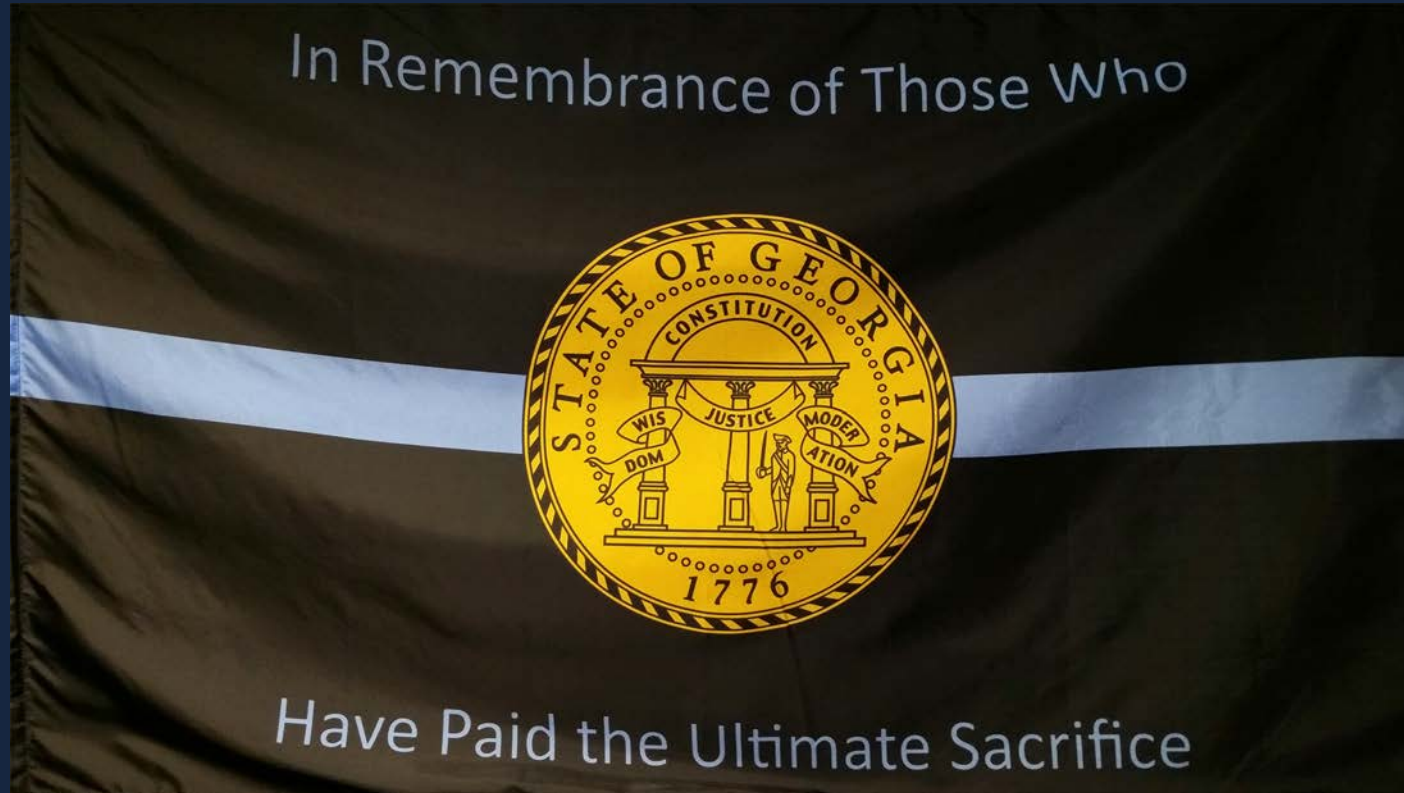
Each stripe on the flag represents certain respective figures in society.
