This Addendum forms a part of the contract documents and **modifies** the original RFP documents as noted below:

QUESTION: ***Basic Nurse Staffing:*** The staffing requirement in the RFP which is what CHC's option 1 was based, does not differentiate between "basic nurse staffing for intake and sick call". The RFP just indicates the total number of FTE's for various titles. Are we supposed to use all of a certain title? If not, how many FTE's by each title does the county identify as "basic intake and sick call"? Should the figure include the benefits or just the salary?

RESPONSE: ***Staff for Intake Medical Screening with RN supervision and LPN screeners. A minimum of three screening nurses available at all times. Include a narrative section in proposal for Intake Screening. Describe screening process and staffing with just salary cost.***

QUESTION: ***Physicians on call- Hourly:*** The annual rate paid to a physician for salary includes the on-call pay. Is the county just asking for the on-call hourly rate which will be split out of the salary rate?

RESPONSE: ***A total annual salary will suffice.***

QUESTION: ***Administrative Cost:*** What exactly does the county want included in the administrative costs: malpractice, travel, recruiting, etc.? Is the county just looking for "administrative staff" such as secretaries, medical record clerks, etc? Or should the administrative section include administrators such as the Director of Nursing, physicians, etc.?

RESPONSE: ***Costs other than salaries, medical supplies, drugs. Eg., insurance, travel.***

QUESTION: ***Pharmacy Administration:*** Does pharmacy administration include pharmacist/pharmacy technician costs only or should this include the cost of the pharmaceuticals? Is there anything else that should go into this category?

RESPONSE: ***Include staffing and annual cost of drugs.***

QUESTION: Specialist itemized – per visit: What specifically is requested for this category?

RESPONSE: *Rate per visit and extend to an annual rate. This represents the cost of the specialty clinics the vendor intends to provide on-site, like orthopedics or optometry.*
