This addendum is in reference to the 12RFP81807C-MT
Food Services at the Juvenile Justice Center

1. The due date and time for this bid has been extended to **11:00 A.M. February 22, 2012.**
2. The due date for clarification and interpretations has been extended to **February 15, 2012 at 5:00 P.M.**
3. On page 34 under waste and rodent control, it states that the Contractor will provide pest control, but the RFP also states in the second paragraph under Recycling Program on page 34 that Fulton County will provide pest services. Which is accurate? Will the county or contractor have to pay for pest control services?
Response: Fulton County will provide pest control services. The Waste Management and Rodent Control paragraph should read as follows:
“Fulton County will provide for grease removal at the Juvenile Justice Center at the County’s expense. Fulton County shall allow the food service provider to dispose of wet garbage in the main dumpster at the Juvenile Justice Center. Fulton County will also provide pest and rodent control for the food service area at the County’s expense. The successful contractor is responsible for notifying the General Services representative/ Customer Service Center via a Work Request for grease removal service. The successful contractor is also responsible for notifying the General Services representative/Customer Service Center via a Work Request for specific pest/rodent problems as they occur.”
4. Can you provide the historical sales data for the last two years? Can you differentiate between the amounts of cafe sales vs. catering sales?
Response: There is no historical data available.


