1. The following is hereby added to the last page of Section 3, Scope of Work and Technical Specifications:
 - The Finance Department requires a Cash Management safe that will store/secure deposits for weekly pickups by the courier from the 141 Pryor street location. The Cash Management safe should have a reporting module that tracks deposits and user activity, provide printed receipts and the ability to accept coin and currency. If a Cash Management safe cannot be provided, deposit pickups will be daily Monday through Friday.
2. The following changes are hereby made to the chart under Section 7, Special Conditions and the Exhibit titled "Pricing Forms for Armored Car Services":
