

Questions and **RESPONSES**

Question 1: Cadet T-shirts (Section 2, letter C) do not have separate line items listed for short sleeve and long sleeve.

RESPONSE: *Long and short sleeve required*

Question 2: Cadet T-shirts (Section 2, letter C) do not have any information concerning embroidery and/or screen-print. Are these shirts to be blank?

RESPONSE: *No embroidery or silk screen*

Question 3: Polo shirts for Deputies (Section 2, number 5) and polo shirts for Detention Officers (Section 2, number 6) do not list any information for logo embroidery, direct name embroidery, nametapes, shoulder emblems, or collar tip embroidery.

RESPONSE: *All deputy/detention should have name and rank embroidery and name and shoulder patches*

Question 4: Sweaters (Section 5) for Detention Officers and Security Specialist do not list any information for chest emblems, shoulder emblems, nametapes, etc.

RESPONSE: *No*

Question 5: There is not a separate section to list charges for embroidery including logos, direct name embroidery, nametapes, collar tip embroidery, etc.

RESPONSE: *The pricing should be include in the price.*

Question 6: There is not a separate section to list charges to sew-on department provided emblems

RESPONSE: *Yes, there is.*

Question 7: There is not a separate section to list charges for screen-print.

RESPONSE: *Screen-printing will be handles under a separate procurement method.*

Question 8: There is not a separate section to list charges for over-sizes. Are over-sizes to be included with regular size pricing?

RESPONSE: *Oversize orders will be handled under a separate procurement method.*

RESPONSE: *Brown Inspiewak.*

Question 10: SECTION 2 A LINE ITEM 2: What color is (035)? Please specify color of Long Sleeve Shirts.

RESPONSE: *Silver tan*

Question 11: SECTION 2 A LINE ITEM 4: What color is (035) Please specify color of Short Sleeve Shirts.

RESPONSE: *Silver tan*

Question 12: SECTION 2 A LINE ITEM 5: What color are the Polo Shirts?

RESPONSE: *Silver, tan and gray*

Question 13: SECTION 2 D: Any embroidery or silk-screening on sweatshirts?

RESPONSE: *No*

Question 14: SECTION 4 A, B: Please advise if the letters on the HIVIZ side of rainwear are black or reflective.

RESPONSE: *Black with reflective lettering.*

Question 15: SECTION 6 C Will the baseball caps be embroidered or emblem applied?

RESPONSE: *Yes, it will have the seven point for deputies gold/brown and six point for detention officers black/gray on the front*
