This Addendum forms a part of the contract documents and modifies the original ITB documents as noted below:

The following change has occurred for the aforementioned ITB:

QUESTION 1: On page 57 it states the base revenue amount starts at \$125,000.00... So this is stating all bid must start at 125,000.00?

ANSWER 1: Yes, the County will not consider any bids below \$125,000.00

QUESTION 2: Are you asking for the lowest bidder in this case?

ANSWER 2: No, the County will award the contract to the highest bidder under this contract.

QUESTION 3: Whatever bid submitted will determine how much Dependable Transport and Towing would pay Fulton County Purchasing Department?

ANSWER 3: Yes

QUESTION 4: If we plan to have fencing up prior to start of contract, will this be sufficient?

ANSWER 4: If no fencing is currently in place, a high bid will still be considered however the security measures must be in place by the first day of the contract. If not, the award will be pulled and given to the next highest bidder.

QUESTION 5: If you've filed bankrupt within the last five (5) years, will this effect approval?

ANSWER 5: No

QUESTION 6: On page 50 it states all payments must be submitted by January 1st of the starting year 2015, is this correct?

ANSWER 6: Yes, the County expects the awarded vendor to be able to pay their fee to the County on the 1st of January of each year the contract is valid.
