The following questions were posed of the aforementioned ITBC project:

QUESTION 1: First, the term of contract dates on page 3, states the commencement term ends on 31 Dec 2014, so when does the contract start?

ANSWER1: Please disregard, this contract will start on January 1, 2016 through December 31, 2016 with two (2) renewal options.

QUESTION 2: Also renewal terms, it states that the second renewal term would start on 1 Jan 2016? I am confused on when the contract starts so can you clarify that for me, and there are two one year renewals after the initial term date?

ANSWER 2: The first renewal will start January 1, 2017 through December 31, 2017. The second renewal will start on January 1, 2018 through December 31, 2018.

QUESTION 3: The price sheet per tire, the bid price per quantity, (1-50), (51-100), and (101-150) is per each order or the aggregate total for the term of contract.

ANSWER 3: This is a unit price contract so therefore give the County your unit price for each category.
