

Addendum Statement

The Addendum Statement should be used for explanation of any additional information needed to complete an accurate filing of this report.

While there is a discrepancy on this report between the total amount of cash contributions and the total amount of cash expenditures that seemingly leaves the Committee with a negative balance of \$1,968.97, the Committee has satisfied all its known outstanding obligations, save the loan from Judge Edlein dated 10/30/09 of \$958.43. This amount was used to satisfy the last outstanding obligation of the Committee to its campaign advisor Landmark Communications. Adjusting for this amount, the discrepancy between contributions and expenditures is \$1,010.54. My best information is that this discrepancy is comprised of math errors and/or some recorded contributions that were accidentally deleted from our contribution tracking sheet. In any event, the Committee's only known outstanding obligation at this date is the \$958.43 loan from Judge Edlein.
