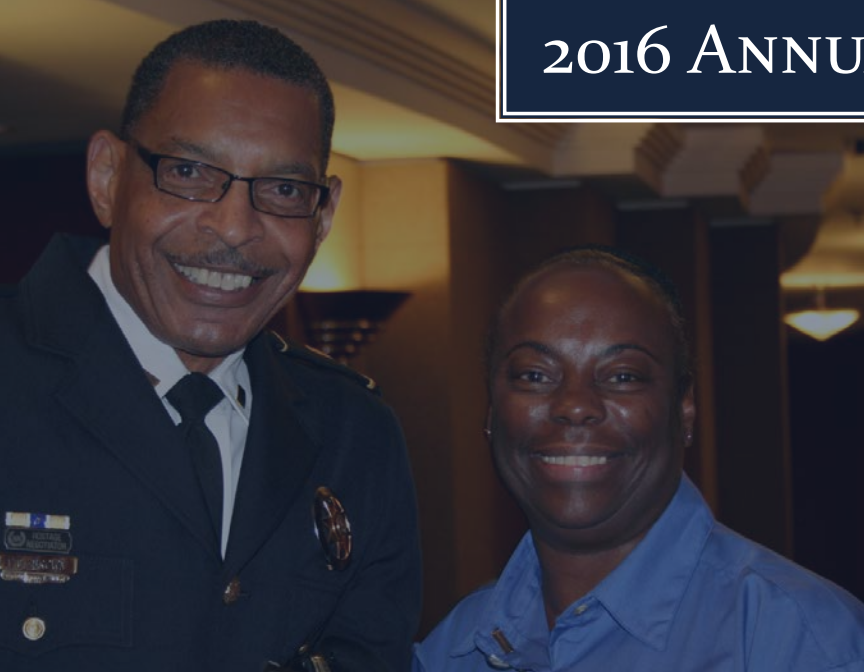

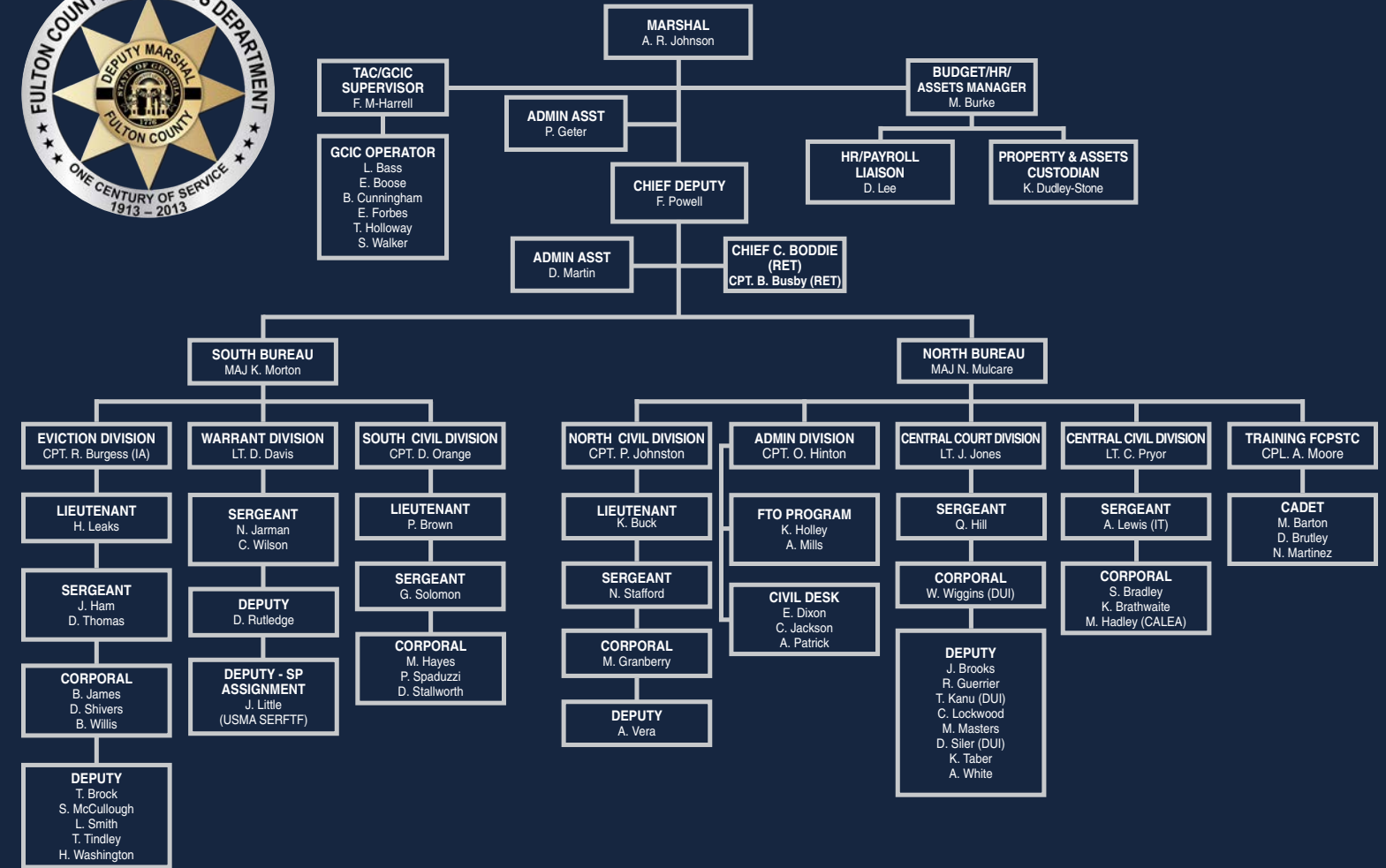
As we phase into the New Year, I ask that you continue to be safe and serve with admiration and compassion.

### UCR Reporting: UCR Project 8111

Successfully implemented, UCR Project 8111, allowing reporting of Marshal's Department crime statistics to the Georgia Bureau of Investigation and the Federal Bureau of Investigation. At the time this was the largest project and only project of this scale and magnitude for Tyler Technologies. This project resulted in Tyler Technologies addition to the GBI list as an approved automated UCR vendor. This project was completed at no cost to the Fulton County Marshal's Department.

## Information Technology

Business Process Review Enhancements Scaling - As a result of the CJIS Business Process review 88 hours of software development hours will be spent to:

- Allows Garnishee information to be pulled from Case Manager to Law Enforcement | Allows non-plaintiff parties to flow from Case Manager to Law Enforcement on Civil Paper for service.

### e-File GA

Successfully implemented the e-File Georgia business process as a collaborative effort with the Superior and Magistrate Courts of Fulton County. A number of assets including but not limited to high speed scanners, work stations, and barcode printers were acquired by the Marshal's Department as a result of this project. To date the Marshal's Department has submitted thousands of documents to the e-File system.

The Marshal's Department is committed to providing a professional and knowledgeable workforce to meet the needs of the citizens of Fulton County and our public safety partners. Training is critical to achieving this mission across all divisions of the Department, including Administration, Civil, Court Services, Evictions and Special Operations. The Training Division had the following highlights in 2016:

- The Physical Fitness & Wellness Program was implemented to improve employee physical fitness levels
- 58 employees completed 700 hours of Physical Fitness Training
- 5 employees completed Basic Peace Officer Certification Training
- 19 sworn employees completed 76 hours of TASER refresher training
- 44 sworn employees completed 88 hours of OC refresher training
- 2 new General Instructors: 1 new Firearms Instructor and 1 new Defensive Tactics Instructor

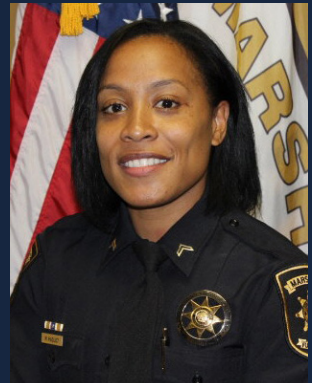

## G.R.E.A.T. Program (Gang Resistance Education and Training)

The goal of the G.R.E.A.T. Program is to help youth avoid gang membership, prevent violence and criminal activity, and develop a positive relationship with law enforcement. This program provides a school-based program that includes classroom instruction and various learning activities conducted by sworn/certified criminal justice professionals.

The program is intended as a deterrent against delinquency, youth violence, and gang membership for children who are near the prime age for introduction to gangs and delinquent behavior. The G.R.E.A.T. curriculum has been delivered to more than 6 million children by trained and certified officers around the United States.

Sergeant Wilson continues to do a great job with the children at Asa G. Hilliard Elementary School, located in East Point.
