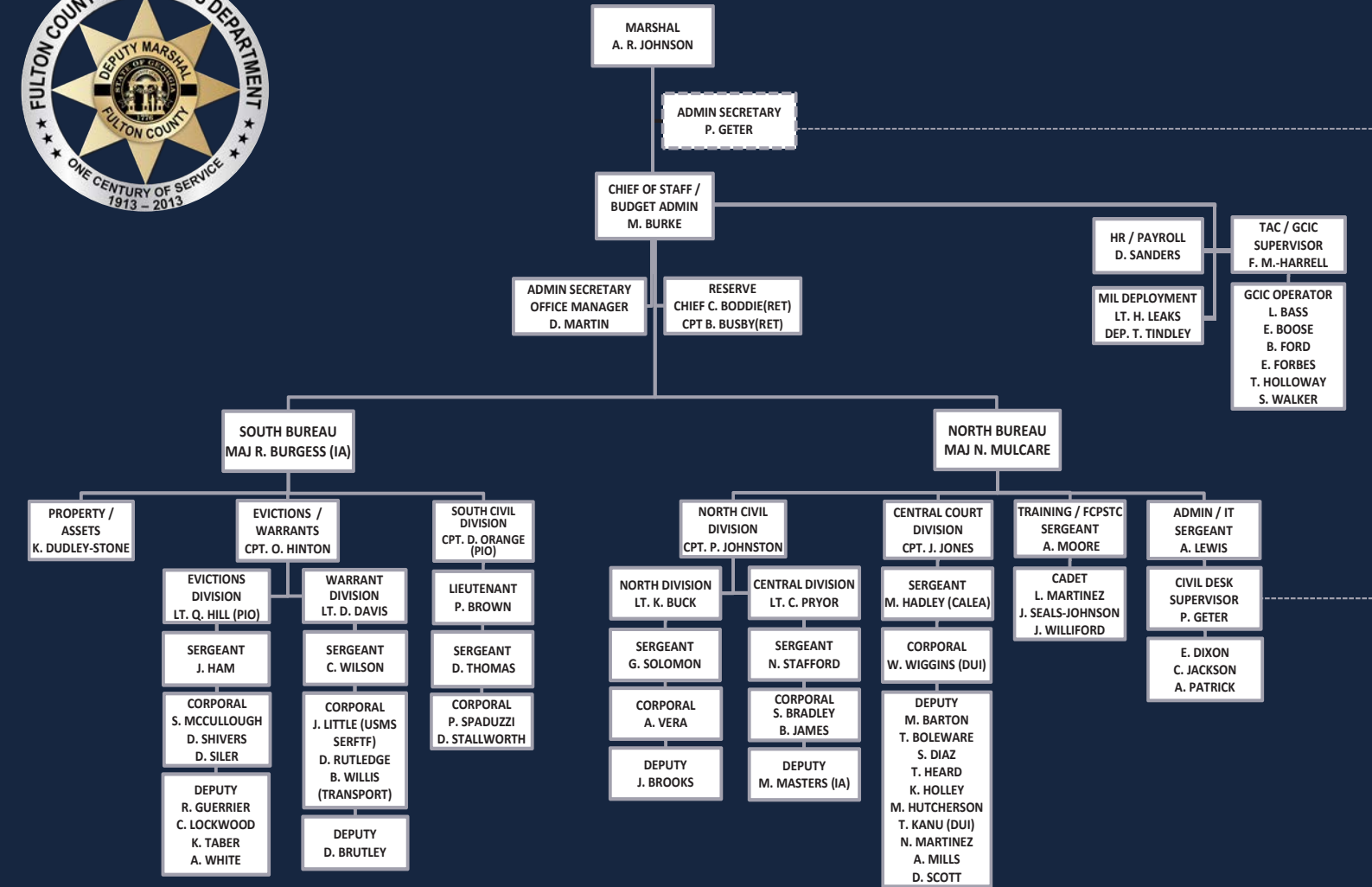
Message from the Marshal

Junior Deputy Program



The Junior Deputy program is designed to build superior character, form leadership skills, promote good citizenship, enhance personal and mental fitness and to possibly interest participants in law enforcement careers.



During the week the program participants toured the Fulton County Courthouse, the 911 Communications Call Center, the Juvenile Courthouse detention facility and the Fulton County Jail. They learned CPR, took a course on Emergency Management Preparedness, Defensive Tactics, Crisis Intervention, Crime scene investigations, Courtroom procedures and the G.R.E.A.T Program. The participants were able to ride along on the Emergency Vehicle Operators Course which is a timed course at the Fulton County Public Safety Training Center that demonstrates skid recovery, braking exercises, parallel parking, safe backing exercises and controlled intersections.

G.R.E.A.T. Program (Gang Resistance Education and Training)

The goal of the G.R.E.A.T. Program is to help youth avoid gang membership, prevent violence and criminal activity, and develop a positive relationship with law enforcement. This program provides a school-based program that includes classroom instruction and various learning activities conducted by sworn/certified criminal justice professions.

The program is intended as a deterrent against delinquency, youth violence, and gang membership for children who are near the prime age for introduction to gangs and delinquent behavior. The G.R.E.A.T. curriculum has been delivered to more than 6 million children by trained and certified officers around the United States.

Sergeant Wilson continues to do a great job with the children at Asa G. Hilliard Elementary School, located in East Point.



Student Intern Program

The Student Internship Program is designed to provide college students with an opportunity to learn about the Georgia Criminal Justice System through observation of courtroom proceedings, field operations and administrative functions. When students complete the Internship Program it is our desire that they are able to satisfy their college internship requirements, gain a better understanding of the criminal justice system and possibly interest them in law enforcement careers.

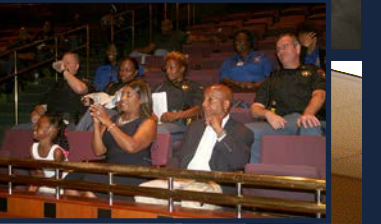

The Marshal's Department is committed to providing a professional and knowledgeable workforce to meet the needs of the citizens of Fulton County and our public safety partners. Training is critical to achieving this mission across all divisions of the Department, including Administration, Civil, Court Services, Evictions and Special Operations. The Training Division had the following highlights in 2017:

- 70 employees, sworn and civilian, completed approximately 500 hours of Physical Fitness Training.
- 6 employees completed Basic Peace Officer Certification Training
- 7 new employees were certified to carry TASERS
- 41 employees completed 174 hours of TASER Refresher Training
- 32 employees completed 240 hours of Defensive Tactics Training
- 25 employees received 164 hours of training in Basic Life Support
- 2 new General Instructors and 1 new Specialized Instructor in Emergency Medical
