



**NOTICE OF FINDING OF NO SIGNIFICANT IMPACT AND
NOTICE OF INTENT TO REQUEST THE RELEASE OF FUNDS**

REQUEST FOR THE RELEASE OF FUNDS

On or about **January 4, 2020**, the *Fulton County Government*, will submit a request to the U.S. Department of Housing and Community Development (HUD) for the release of *Community Development Block Program (CDBG)* funds which provides annual grants on a formula basis to states, cities, and counties to develop viable urban communities by providing decent housing and a suitable living environment, and by expanding economic opportunities, principally for low- and moderate-income persons. The program authorizes funds under **Title 1 of the Housing and Community Development Act of 1974, Public Law 93-383**, as amended **42 U.S.C.-530.1** et seq. to undertake the following CDBG projects as outlined below located in areas of Fulton County including College Park, East Point, Fairburn, Palmetto and South Fulton Georgia, respectively.

PUBLIC COMMENTS ON FINDINGS

Comments should specify which Project Activity they are addressing.**

RELEASE OF FUNDS CERTIFICATION

The *FULTON COUNTY, GEORGIA* certifies to *HUD Georgia* that *Dr. Pamela Roshell* in her capacity as *Interim Director* consents to accept the jurisdiction of the Federal courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. *HUD Georgia* approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the *Fulton County Government* to use CDBG Program Funds.

OBJECTIONS TO RELEASE OF FUNDS

***HUD Georgia* will accept objections to its release of funds and *Fulton County, Georgia's* certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are made on one of the following bases: (a) the certification was not executed by the Certifying Officer of the *Fulton County, Georgia*; (b) the *Fulton County, Georgia* has omitted a step or failed to make a decision or finding required by U.S. Department of Housing and Urban Development regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by *HUD Georgia*; or (d) another Federal agency acting pursuant to 40 CFR part 1504, has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted via email in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the Atlanta CPD Field Office at CPD_COVID-19OEE-ATL@HUD.gov. Potential objectors should contact the *Atlanta CPD Field Office* via email to verify the actual last day of the objection period.**
