LAW CORNER

Constructive Possession of a Firearm

For those who are entrusted with firearm prosecutions, a defendant need not have actual possession of a firearm in order to be liable for possession of a firearm during the commission of a felony or possession of a firearm by a convicted felon charge. Constructive Possession applies when we can present direct or circumstantial evidence to support that the Defendant "knowingly has both the power and the intention at a given time to exercise dominion or control over a thing, and it must be based upon some connection between the defendant and the contraband other than spatial proximity." Murray v. State, 309 Ga. App. 828, 830 (2011). This essentially means that we simply can't say that the defendant was in the mere presence of a gun, but that they had the ability exercise control over it in some way shape or form. Additionally, if the Defendant is a party to a crime or co-conspirator to other individuals who are in possession of a firearm, then the fact that they are an active participant in effectuating the crime while not directly possessing a firearm (i.e. being the getaway driver or lookout) can make them liable for possession of a firearm related charges. See Scoggins v. State, 317 Ga. 832 (2023).

Randolph is currently the Executive Deputy Chief Investigator for the Fulton County District Attorney's Office serving Madam Fani T. Willis. Randolph handles the High Profile Case Difficult Witness Task Force and Technology Unit aka "HP Plus". He formerly served as Deputy Chief Investigator in the Cobb District Attorney's Office. He was also the Chief Investigator for the DeKalb Solicitor General. Randolph is a product of Morris Brown College and Strayer University. He is actively involved in Alpha Phi Alpha Fraternity and Kingdom of God Ministries in the City of South Fulton, and he gives lessons in trombone and baritone to Atlanta Public Schools students through the Gift of Music Foundation. Randolph is the current Vice President and Founding Member of The 100 Black Men of Douglasville. Johnna Griffin is a 22 year veteran of law enforcement and a graduate of Georgia State University with a Bachelor of Arts degree in Psychology and Sociology (Criminology). She first served as an officer with the Fulton County Police Department and was promoted to Detective and later Sergeant in the units of Major Case, Homicide, Special Victims, Sex Crimes, Missing Persons, Domestic Violence, White Collar, Juvenile, Burglary, Field Training, and Agency Accreditation. Johnna is also a Georgia P.O.S.T. Certified Instructor, Hostage Negotiator, Crime Analyst, and Special Weapons and Tactics team member. She holds certifications in executive protection and supervisory management.

Johnna spent over a decade investigating numerous high profile cases that resulted in prosecutions and convictions with Fulton County Police and other federal agencies. She then joined the Fulton County District Attorney's Office in 2007. She has served as a senior investigator in every unit and as an Assistant Chief in Trial Division, Major Case, and Special Investigations. She was promoted to the Deputy Chief of Investigations while simultaneously supervising Major Crimes and conducting Death Penalty and Cold Case Investigations.

Yolanda R. Mack is currently the Deputy District Attorney for the Sexual Assault Unit at the Fulton County District Attorney's Office. She is currently responsible for leading a team of Senior Assistant District Attorneys in prosecuting felony cases of sexual assault against adult victims. Her duties and responsibilities include supervision of Unit attorneys, evaluating and mentoring attorneys; conducting periodic unit meetings; reviewing and approving requested leave time; assisting in developing policies and procedures for the Unit; assisting in developing goals and objectives for the Unit; ensuring courtroom coverage for all court dates; liaison between department management and the Unit; reviewing and approving transfer cases; participating in related trainings and community outreach; reporting to the Director of the Special Victims Unit.



OUR INTERNS OUT & ABOUT



The Fulton County District Attorney's Office Internship program offers a rigorous 9-week opportunity for students to delve deeply into the world of prosecution. Each summer, approximately 50 interns from diverse backgrounds and educational levels participate in a comprehensive program that includes field trips, guest speakers, hands-on experiences, and more.

Throughout the 9 weeks, interns engage in a variety of off-site field trips, including visits to the Fulton County Medical Examiner's Office, the GBI Crime Lab, the King Center, Fulton County Superior Court, the Supreme Court, the Georgia Capitol, and other criminal justice significant locations. Additionally, interns benefit from the wealth of knowledge within the office through events like "Launch & Learns" and "Coffee & Conversation," covering topics such as gangs, animal abuse, opening and closing statements, and career-defining cases.

Interns are assigned to a division or unit based on their individual backgrounds, interests, or academic degrees. Regardless of their educational level, all participants learn how to prepare a case thoroughly, from its inception to indictment/accusation, providing invaluable hands-on experience in case preparation before court proceedings. Law school interns often have the opportunity to present cases in court, including arguing motions alongside their supervising attorneys or negotiating pleas.

One of the program's highlights is the Mock Trial competition, immensely popular among interns and office staff alike. Interns form teams led by office attorneys who serve as mock trial coaches. Teams are tasked with preparing for a fictitious criminal case, developing strategies for opening statements, closing arguments, witness testimonies, and more. This competition spans two intense days, including a double elimination round, showcasing the interns' legal skills and competitive spirit.

To conclude the summer program and honor the interns' dedication, the office hosts a graduation ceremony where interns, their families, and staff come together to celebrate their achievements.



GBI CRIME LAB TOUR

In June, FCDA interns had the incredible opportunity to tour the GBI Crime Lab. Established in 1952 as the second statewide Crime Laboratory in the United States, the Division of Forensic Sciences provides scientific support to Georgia's Criminal Justice System (GBI Website).

With assistance from lab staff, students met laboratory scientists and technicians specializing in various disciplines. They learned about the collection, analysis, and interpretation of physical evidence. Such evidence is crucial for officers, investigators, and prosecuting agencies statewide. Students also gained insight into the crime lab's integral role in FCDA's efforts to prosecute cases effectively.

Highlights of the tour included demonstrations such as ballistics testing with a weapon firing vat and range, advanced robotic and computer systems in the drug lab, as well as techniques like latent printing and trace testing. The FCDA deeply appreciates the GBI's dedication and for taking the time out of their busy schedules to provide guidance and engage in a robust Q&A session with the interns.

MEDICAL EXAMINER'S TOUR



On the June field trip tour, some of the FCDA interns visited the Fulton County Medical Examiner's Office. They toured the FCME facility and participated in a morning informational session with the doctors and staff preparing them for the tour. The interns learned that the FCME's primary goal is to determine the cause and manner of death for certain decedents and how they are determined to fit their criteria. During the tour, the interns observed a full autopsy and received valuable insights from the dedicated staff. They learned firsthand how determining the manner of death is a critical aspect of death investigations and why this information is essential for prosecution offices. Understanding these processes renewed the interns' commitment to learning about prosecution and advocating for victims.

On Friday, June 14, 2023, Assistant Chief Investigator Brian Salters attended the 100 Black Men of America's conference in Atlanta, GA. Investigator Salters led a team from the Savannah Police Department, Chatham County Police Department, Fulton County Sheriff's Office, and Clayton County Public Schools to present a program for the National Organization of Black Law Enforcement Executives (NOBLE). The team conducted a workshop with approximately 100 middle school students and 150 high school students from across the country.



Our recent Diversion and Records Restriction event, in collaboration with GA Workforce, was a tremendous success. We welcomed 66 citizens seeking employment, and showcased the impactful programs offered by the District Attorney's Office. We processed applications for record restrictions, provided crucial information about our unique Adult Diversion program, and established valuable partnerships with over 20 vendors ready to hire and support future events. We are excited to announce the upcoming Game Changer Adult Diversion Clinic on July 10, 2024, at the Fulton County Government Center, with on-the-spot hiring by partner Freight on Wheel Express. Key attendees included Legal Assistant Caderrius Armstrong, Investigator Harold Milanes, Diversion Case Manager Mike Passmore, Deputy DA Ms. Ramona Toole, and Adult Diversion Director Ms. Epiffany Henry.

The Byrne Grant is focused on two high-crime hotspots: Fairburn Mays in the City of Atlanta and Red Oak in the City of South Fulton. These areas have been disproportionately impacted by crime and violence within Fulton County. The leadership team, consisting of Assistant District Attorney Samia Giddings and Investigators Lawrence Vazquez and Nicole Whigham, has engaged a wide variety of stakeholders to collectively identify the issues and means of addressing challenges in the community. A review of official crime statistics conducted by Applied Research Services, along with anecdotal reports from community leaders and members, indicates that apartment residents in these hotspots have been subjected to crimes including robbery, vandalism, destruction of property, car thefts, auto break-ins, and various violent offenses. It has become clear that the official statistics do not tell the whole story and almost certainly reflect gross under-reporting.

Further compounding matters is the lack of healthy options and supportive services for youth in these communities. Youth are at higher risk of becoming gang-involved if they engage in delinquent behavior, are predisposed to violence, and have few if any options for healthy engagement and support within their communities.

In June 2024, the Byrne Grant Team is supporting a summer camp in South Fulton facilitated by the Police Athletic League. A few of our interns spoke to the kids about college life, their future aspirations, and why they are interning at the DA's office. Assistant District Attorneys Asia Baysah, Jazmin Dilligard, Kendall Watkins, and Intern Hannah Perdue spoke to the students about Teen Dating Violence. The students were able to role-play what unhealthy dating looks and feels like to them. Afterwards, Chief Meadows and several officers spoke about their experiences in law enforcement and why violence happens in our communities. They discussed the lack of emotional intelligence young people possess and why they are not able to communicate effectively when someone upsets them or hurts their feelings.

The Byrne Grant team also assisted the PAL summer camp in taking the kids on two college tours (Morris Brown College and Georgia Tech), to the MLK Center, and organizing their very own field day.
