## State vs. Nicholas Golden

On May 5, Senior Assistant District Attorney Sau Chan, Assistant Chief Saul Alter, and Investigator Christy Manos successfully concluded the sentencing in State vs. Nicholas Golden, where the sentencing terms required the Defendant, an operator of a used car sales business in Union City, Georgia, to pay combined restitution of \$20,707.21 to seven victims who had purchased used cars from the defendant based on fraudulent emission certificates generated by the defendant when he was operating as an emission inspector in 2016-2017.

The Defendant's sentencing took place almost four months after he entered a guilty plea in January to all the charges in a 35-count indictment that comprised one count of Racketeering; 17 counts of False Statement; and 17 counts of False Official Certificates or Writings. As part of his sentencing, the Defendant also was ordered to surrender his auto sales business license and to shut down his auto sales business. Thanks to AC Saul Alter for tracking down some hard-tofind victims and Investigator Christy Manos for her dedication.

# HealthyPETS FULTON





On May 12 the Fulton County District Attorney's Office, in partnership with Lifeline Animal Project and Commissioner Abdur Rahman, held "Healthy Pets Fulton" at the Westside Reservoir park. The event offered a veterinary exam with vaccinations, microchipping, and spay/neuter vouchers for dogs and cats. Residents were also offered pet supplies such as food, leashes, collars, bowls, and toys. All services were completely FREE! District Attorney volunteers provided important information regarding domestic violence, human trafficking, record restriction, adult diversion, and elder

abuse. We also distributed informational magnets to educate the public about safe pavement temperatures and the dangers of unattended cars to pets and children.

The event provided services to **835 dogs and cats**. By alleviating the financial stress related to basic care we hope prevent unnecessary surrenders and keep pets in homes that love them. Crimes against animals are closely related to crimes against humans and often act as a precursor to escalating harm. The information provided to attendees educate about the risks and provide contact information for safe reporting of these offenses.

## National Crime Victims' Rights Week in Fulton County and Self-Care

National Crime Victims' Rights Week (NCVRW) has been celebrated each April since its inception in April 1981. This year, the event took place in the last week of April with the theme - Survivor Voices: Elevate. Engage. Effect Change. The event urged communities to amplify survivors' voices and to commit to creating an environment where survivors are heard, believed, and supported (Office for Victims of Crime, 2023). This year, the Victim Witness Assistance Program created a committee comprising advocates, survivors, and crime victims. Victims and survivors agreed that they did not want another event that would leave them sad or upset; they wanted to feel empowered and uplifted. They also did not want more speeches from community officials. Thus, this year's event developed into a self-care week.

• April 24: Meditation Monday. Meditation is very beneficial for self-care because it can assist with reducing stress and anxiety along with other health benefits (Corliss, 2014). Participants enjoyed aromatherapy, soothing sounds, and engaging in relaxing body motions.

• April 25: Self-defense class. Self-defense fits with self-care as it can bolster an increased sense of personal safety and awareness. The instructor provided techniques to assist with releasing oneself from restraint if an individual is being strangled or grabbed involuntarily. The instructor also provided tactics and tips and allowed class participants the opportunity to practice. The tactics were beneficial in both public and private settings.

• April 27: Firearm safety class. This education is beneficial for self-care by increasing personal safety and awareness. The instructor had everyone discuss their plan of action if an intruder enters their home. Most participants had never thought about or created a plan of action for a home invasion before. The instructor had all students practice how to safely handle and unload a weapon – a must for those who own firearms or plan to purchase a firearm. Each participant was given a free firearm lock to prevent

accidental discharge.

The main event on April 29 was the Fani T. Willis Self-Care Fair. The event brought together victim-service providers and vendors, including massage therapists, barbers, make-up artists, a meditation specialist, and caricature artists. A popular vendor created treats and provided decadent and delicious fried Oreos. More than 130 victims, survivors, and staff members participated in this event that aimed to provide emotional, mental, and physical benefits.

Self-care is important to everyone, including employees of this office and the community. It would be beneficial to participate in any of these activities. # LAWCORNER

In homicide cases, prosecutors usually introduce what is called an "in-life" photograph of the deceased - a carefully selected photograph provided by the family to introduce into evidence when the case goes to trial.

It's an opportunity to humanize the victim, who would otherwise be nothing more than a name, a case number and a corpse in autopsy photographs.

But the purpose of the in-life photo is not simply to provide an emotional connection for jurors. It has a legal purpose. The Supreme Court of Georgia has held that in a murder case, "a photograph of a victim in life may be relevant to prove an element of the corpus delicti, that is, that the person alleged to have been killed is actually dead." Ragan v. State, 299 Ga. 828, 832 (2016); see also Walker v. State, 312 Ga. 232, 238 (2021). Essentially, an in-life photo is relevant to prove the victim was "alive" at one point prior to being killed. Typically, as in the cases cited above, defense attorneys will object to the introduction of the photograph on the basis that it is impermissible character evidence or not relevant. Should the trial court

be persuaded that you are trying to tug at emotional heartstrings, you can provide the judge with these case citations to show why the photo is relevant to the prosecution. The Supreme Court in Walker does provide guidance on steps that should be taken to ensure the probative value of the photo is not substantially outweighed by any unfair prejudicial impact.

The Supreme Court stated that these photographs should only depict the victim and that it is encouraged that the photograph be introduced through a fact witness, if possible, rather than having a family member testify for the sole purpose of introducing the photographs to avoid an understandable emotional reaction from the family member.
