# LAW CORNER

Authentication of Evidence

Under O.C.G.A. 24-9-901(a), "[t]he requirement of authentication or identification as a condition precedent to admissibility shall be satisfied by evidence sufficient to support a finding that the matter in question is what its proponent claims." Therefore, if a document, photograph, recording, etc., is intended to be introduced into evidence, the relevant witness through whom we are introducing such items must sufficiently indicate what the item is and how they have knowledge of it.

The Court of Appeals recently addressed authentication in the context of the prosecution admitting a Facebook snapshot taken by the detective involved in the case (see Johnson v. State A23A1029, 10/12/23). Although the Defense attempted to object to the introduction of the snapshot, the trial court, and ultimately the Court of Appeals, found it permissible for the detective to authenticate the photo from the Defendant's Facebook page, later used to identify the Defendant as the perpetrator of the crime.

The Court of Appeals held that "[D]ocuments from electronic sources such as printouts from a website like Facebook are subject to the same rules of authentication as other more traditional documentary evidence and may be authenticated through circumstantial evidence." In Johnson, the detective identified the photo of the defendant on her Facebook page as a snapshot taken on her computer, and confirmed that the Facebook page bore the Defendant's name. Consequently, she sufficiently authenticated it, and no additional steps were needed beyond what is outlined in the statute.

## F.C.D.A.O. IN THE COMMUNITY



In December, Executive DA Kenneth Hutcherson and Deputy DA RuShondra Davenport served as faculty members for the Prosecuting Attorneys' Council of Georgia (PAC) Basic Litigation Boot Camp. DDA Davenport will serve once again when the next boot camp occurs this coming April.



The Atlanta Volunteer Lawyers Association (AVLA) Know Your Rights sessions represent the purest form of service through empowerment. Fulton County Clerk Ché Alexander and Deputy District Attorney Ramona Toole directly addressed South Atlanta parents and community, providing valuable information about record restriction opportunities. This knowledge empowers individuals to secure and maintain safe and habitable housing. This month, on January 10th and 11th, technical advisors for our grant, 'Family-Based Alternative Sentencing,' flew in to meet the grants team. Our DV Team was represented by Deputy District Attorney Asia Baysah, Deputy Victim/ Witness Advocate Dilma Dos Reis, our Diversion Team represented by Deputy District Attorney Ramona Toole and Adult Diversion Director Epiffany Henry, CAC Deputy District Attorney Lauren McAuley, Chief Deputy District Attorney Rewa Collier, representatives from the Probation Office, supervisors from the Fulton County Public Defender's Office, and our partner providing therapy, Families First. The discussion aimed to explore treatment and accountability for parents/caregivers in the criminal justice system.

Our two-day discussion focused on options to allow parents to remain with their dependent children while under supervision. Prioritizing diversion programming is crucial to our boss, Fulton County District Attorney Fani T. Willis. The Adult Diversion Program, created by DA Willis, provides defendants, generally first-time offenders, with alternatives to the traditional criminal justice process of ordinary prosecution.

We are aware that children who are victimized and exposed to violence are more likely to suffer from depression, anxiety, and post-traumatic disorders, fail or have difficulty in school, and become delinquent and engage in criminal behavior. Youth are at higher risk of joining a gang if they engage in delinquent behaviors, are predisposed to aggression or violence, experience multiple caretaker transitions, have multiple problems at school, associate with other gang-involved youth, or reside where neighborhood juvenile crime exists. We aim to minimize influences of neglect or trauma in their childhoods, which may increase the chances of children entering the criminal justice system themselves.

To expand our reach to serve children, the DV Unit along with CAC is considering the process to offer a Conditional Plea for those who do not qualify for diversion and complete therapy and the mandated Family Violence Intervention Program (FVIP). The grant funding will cover the costs of therapy, classes to learn co-parenting, and improve parenting skills. The objectives are to reduce the likelihood of future involvement in the criminal justice system, improve parental attachment, and eliminate the family violence a child is exposed to.
