Fulton County Marshal's Department IT Projects for 2015

Wireless Card and Hotspot Upgrade

On October 10, 2015, the Marshal's Department upgraded all mobile broadband cards (air cards). These air cards allow for wireless access to the network in the field. With this access deputies in the field can email, fax, and listen to telephone messages in the field. In addition, deputies in the field are also able to access the records management system, Odyssey. Therefore, this allows for the updating of records in the field which provides real-time updates to customers.

Odyssey Records Management System Upgraded

In September 2015, the Odyssey records management system was upgraded. As a result additional functionality was provided by development projects to improve the systems use in Fulton County.

Odyssey Servers Upgraded

In December 2015, the Odyssey records management system servers were upgraded.

Tyler Project 8111

This project is currently underway and will automate GCIC Uniform Crime Reporting to the GBI. The status is currently under configuration.

Tyler Project 9206

This project's goal is to improve the data transfer from the Law Enforcement Product center to the Case Manager Product center.

Hardware Upgrades

Several desktop, laptop, printers and voice over IP (VOIP) phones were added to our inventory to improve connectivity and productivity.

G.R.E.A.T. Program

The G.R.E.A.T. Program stands for Gang Resistance Education and Training. This program provides a school-based program that includes classroom instruction and various learning activities conducted by sworn/certified criminal justice professionals. The program is intended as a deterrent against delinquency, youth violence, and gang membership for children who are near the prime age for introduction to gangs and delinquent behavior.

The goal of the G.R.E.A.T. Program is to help youth avoid gang membership, prevent violence and criminal activity, and develop a positive relationship with law enforcement.

Sergeant Wilson is one of more than 13,000 officers from around the United States and various Central American countries who have been trained and certified to teach the G.R.E.A.T. curricula, which has been delivered to more than 6 million children. Sergeant Wilson has done an outstanding job with the children of Asa G. Hilliard Elementary School, located in East Point, GA.
