Director Williams greeted the BRE and the public on the Official and Complete election material the BRE will review during Pre-Certification:

Chair Allen requested the BRE ratify the request to review the Scanner Zero Tapes due to that document not listed in the Canvassing Policy.

Chair Allen entertained a motion to review the Scanner Zero tapes to the pre-certification documents. The motion was made by **Ms. Adams**, seconded by **Mr. Selby**, and carried by a unanimous vote of 4-0.

Mrs. Crawford inquired on the purpose for reviewing Scanner Zero tapes. **Mrs. Crawford** mentioned the policy that declares when a member can request additional documents:

Any Board Member wishing to review the above listed documents must make their request with reasonable advance notice. Such Board Member must also complete a BRE Pre-Certification Review Request Form and submit it to the Election Supervisor. The Board member shall then be escorted and accompanied by Staff while reviewing the requested materials. All requested documents will be available for Board Members to review, in the presence of a staff member, beginning 9:00 a.m. on the Monday after the election and continue until the certification of the election results.

Any identified concerns must be formally documented and include the date the discrepancy was discovered along with the signature of the Board member who discovered it. During the review process, Board members shall not photograph, photocopy, transmit physically or electronically, or make available for viewing to non-Board members, any election documents.

Staff shall compile every available requested document during the 6 (six) day certification window.

Ms. Adams explained that those are the numbers the BRE is supposed to be reviewing to certify an election. She cited **§ 21-2-493**.

Chair Allen commented that the BRE discusses this further during the January meeting to take a second look at the statue cited by Ms. Adams, the Canvassing policy, the appellate court decision, and ensure legal counsel is present.

Mr. Selby asked **Director Williams** explained what the Scanner Zero tapes are being requested.

Director Williams explained that it is a print-out of votes cast on each BMD machine by the Poll manager on the first day during Advance Voting and on Election Day. That receipt should always have **0** votes on each BMD. She recommended that the BRE add Scanner Zero tapes to their policy.

Director Williams informed the BRE that during a recent SEB Hearing regarding scanner tapes from **5** years ago in 2020 with missing signatures. Those tapes are valid, but the managers inadvertently did not sign them.

Resolution: To ensure that poll workers understand the importance of all signatures, Call poll workers in to sign during process reconciliation and re-train

Mr. Selby inquired about the appellate court decision and prematurely decided to add Zero scanner tapes to the pre-certification material

Chair Allen outlined that the current bi-partisan policy, put together with input from the DRE and legal counsel. The board should not preemptively decide altering policy based on one member. She highlighted the importance of following the policy and reiterated discussing in January 2026.

Mr. Selby asked **Director Williams** is it an administrative burden to produce the Zero Scanner Tapes.

Director Williams responded no.

Chair Allen asked the BRE regarding Certifying the Election Results today due to size and the official and complete election results presented to the board.

Mrs. Crawford answered that she could review her data and balance because it was approximately 2,400+ voters with 17 polling locations.

Ms. Adams answered that she's unsure, but she can't commit to certifying.

Chair Allen asked the BRE based on the responses, would they like to adjourn and return Monday instead of staying all day on the possibility of a member being prepared to certify.

Ms. Adams suggested that we review election material for 1 hour to determine if the BRE will need to meet on Monday, December 22nd.

Mrs. Crawford agreed with **Ms. Adams**' suggestion.

Chair Allen suggested the Board conduct pre-certification until 12:30pm.
