#1– APPROVAL OF AGENDA

Chair Allen entertained a motion to approve the agenda. The motion was made by **Mr. Selby**, seconded by **Mrs. Crawford**, and carried by a unanimous vote of 4-0.

Director Williams informed the BRE that the DRE Recount of the Election Results were ongoing and as results are uploading the Information Systems Manager (Mr. Ross) will upload Official and Complete Results to each of their devices.

Ms. Adams inquired about Executive Session.

Chair Allen reminded members that they agreed on Executive Session on last Friday.

Chair Allen entertained a motion to close the regular session and convene into executive session to discuss litigation matters. The motion was made by **Mr. Selby**, seconded by **Mrs. Crawford** and carried by a unanimous vote of 4-0.

Mr. Selby inquired about reconciliation report.

Chief Glenn explained that discrepancies on that report occur when one or all the 159 counties in Georgia began processing Voter Registration Applications.

Director Williams explained that voter maintenance occurs daily but during the reconciliation period the DRE will implement procedural remedies to resolve discrepancy.

Ms. Adams inquired about the allocations and the number of votes cast for this low turnout election. She expressed concern over the resources used for this election.

Director Williams responded that the allocation for this election was based on City of Atlanta versus 4 other Municipalities. City of Atlanta closed at 8pm and all other cities closed at 7pm.

Ms. Adams inquired about the paperwork from L&A testing paperwork there seems to be a discrepancy. She asked when the paperwork was completed.

Director Williams answered yes today, handwritten by real people.

Ms. Adams outlined her perceived discrepancy.

Chief Glenn responded that the information is correct because it's only one test deck.

Test deck:

is a set of carefully constructed, sample data (ballots) used to verify systems, or processes by running them through an application to check for accurate results, control compliance, or logic, comparing the actual output with known correct outcomes to find errors or confirm functionality in areas like [accounting systems](#) or [election software](#).

Director Williams responded that **Ms. Adams** has had this paperwork since 11:00am and the question could have been asked and answered earlier. (Current time 9:24pm) She requested **Mr. Ross** leave his station to explain the L&A testing paperwork.

Mr. Ross explained that the paperwork, the process, and the accuracy of the paperwork.

Ms. Adams asked why the scanners were not sealed in the warehouse.

Mr. Ross explained that the scanners are housed in the server room.

Director Williams expounded on **Mr. Ross'** response that the scanners are housed in a Glass dome, secure server room with high level access only.

Mr. Selby commended the staff on the issues that were brought forth and efforts by the DRE to ensure accuracy of the process. He expressed frustration of a member casting disparaging on the DRE, and it only serves as a distraction to the important work that we are doing in Fulton.

Ms. Adams responded that she has the right to ask questions.
