Chair Allen announced that the special called meeting was due to irregularities found at a specific precinct on Election Day. She said the meeting was called to get an update prior to the recount of the December 2, 2025, Election that will commence at 9am today.

#1- APPROVAL OF AGENDA

Chair Allen entertained a motion to approve the agenda. The motion was made by **Mr. Selby**, seconded by **Mrs. Crawford**, and carried by a unanimous vote of 4-0.

#5-BRIEFING ON THE RECOUNT

Impacted Contests:

Atlanta Board of Education D6

Atlanta Board of Education D8, At Large

Director Williams briefed the board on preliminary findings regarding the unlawful occurrence at an Election Day polling location:

The Poll Manager reported that an Assistant Manager had been observed scanning a few ballots at the polling site. Upon review and questioning, it was confirmed that the Assistant Manager scanned five ballots; however, one of those ballots was her own. Four ballots were improperly cast on behalf of family members residing in her household who were not present at the precinct. This is a clear violation of election law. The Poll Manager acted appropriately and promptly in reporting this matter to our office. The Assistant Manager was immediately escorted off the property, and both the Georgia Secretary of State's Office and the Fulton County Police Department were notified in accordance with established protocol. The Georgia Secretary of State and the State Election Board will investigate and determine the consequences of the poll worker's actions.

Director Williams announced that all races will be recounted in accordance with the listed statute:

O.C.G.A. § 21-2-495

b) In precincts where voting machines have been used, whenever it appears that there is a discrepancy in the returns recorded for any voting machine or machines or that an error, although not apparent on the face of the returns, exists, the superintendent shall, either of his or her own motion or upon the sworn petition of three electors of any precinct, order a canvass of the votes shown on that particular machine or machines. Such canvass may be conducted at any time prior to the certification of the consolidated returns by the superintendent.

Director Williams explained the protocols in place to address incidents as described. She explained that it did not impact any election results.

Ms. Adams asked why the BRE was not informed sooner.

Director Williams responded that moving forward the BRE will be informed when communication is sent to SOS for investigation

Ms. Adams asked the DRE when was the last time they conducted a recount.

Director Williams answered during the 2023 Municipal election due to minor discrepancies and some close contests. She reiterated that it did not impact any of the contests.

Ms. Adams inquired on the length of time the recount will take.

Director Williams responded by 3pm.

Ms. Adams asked will the results change.

Director Williams responded that the results should not change.

Ms. Adams asked **Director Williams** do the DRE normally call a special meeting for Recounts.

Chair Allen informed the BRE that she called the meeting in accordance with the BRE By Laws.

Ms. Adams asked **Chair Allen** did she inform the BRE.

Chair Allen answered yes, the BRE was informed via email.

Ms. Adams denied receiving notice of this meeting

Ms. Waller (EA) informed the BRE of the notice that was sent out at 7am yesterday morning to meet the mandated 24-hour notice. Ms. Waller informed the BRE of notices that they receive from External Affairs:

- BRE Meeting Notices
- BOC Meeting notices
- Notices relevant to Elections

Mrs. Crawford suggested that Information Technology (IT) Team assist Ms. Adams with her device to ensure she's getting the communication that is sent out.

Mr. Selby asked about employment status of the poll worker.

Director Williams explained that Election Day poll worker works one day/ temporarily for county not the staffing agency.

Mr. Selby asked who will conduct the investigation.

Director Williams explained that the information is given to SOS to investigate and they will contact the DRE with inquiries, if needed.

Chair Allen suggested an independent investigation conducted by the department.

Director Williams responded that the DRE conducts a review and possible implement changes or additions to SOPs.

Ex: Ensuring poll workers are not placed at their assigned precincts on Election Day

Mr. Selby asked how often do the DRE report incidents to SOS.

Director Williams answered jokingly every election but it's never to this level.

Ex: Campaigning within restricted areas or voters taking pictures of ballot

Mr. Selby asked will the poll worker involved work the Special Runoff on December 16th.

Director Williams answered NO.

Mr. Selby commended the DRE on the process but requested to be informed the day the incident occurred.

Director Williams agreed to real-time communication moving forward.

Chair Allen agreed with **Mr. Selby** on receiving real-time communication and maintaining confidentiality while the DRE is conducting their preliminary investigation.

EXECUTIVE SESSION

The Board did not convene into Executive Session.

ADJOURNMENT

There being no further business, **Chair Allen** entertained a motion to adjourn. **Mrs. Crawford** moved to adjourn the meeting; **Ms. Adams** seconded the motion. There being no further business on the agenda, the Board adjourned the meeting at 9:03 a.m.
