#3- APPROVAL OF THE MINUTES

Regular Meeting- June 12, 2025

Secretary Bodison responded that during the months of elections there will be multiple meeting minutes; however, it's been the practice of this Board to approve during their regular meeting the following month.

Chair Allen requested Attorney Alexis opine.

Attorney Alexis reviewed the Open Meetings Act:

#4- ELECTION PREPARATION UPDATE: Special Election on August 26, 2025

Director Williams greeted and provided a brief overview of election operations:

- Prepared for the July 15th Special Primary Runoff Election (PSC)
- Successful with minimum occurrence
- 4K+ voters cast ballots for AV
- 15K+ voters cast ballots for ED
- 100+ voters cast ballots for ABM
- 30+ voters cast ballots for provisional ballots
- Currently preparing for the August 26th Special Election for State Senate D21

#5- REVIEW OF APPROVED AV LOCATIONS FOR THE SPECIAL ELECTION OF AUGUST 26TH

Senate Seat 21

- Alpharetta Library
- Milton Library
- Registered voters: 70K
- Impacted voters that reside in the Alpharetta, Roswell and Milton
- AV Dates and Hours:
 - August 4-16th Hours: 9-5pm
 August 18-22nd Hours: 9-6pm
 - Saturday voting no Sundays
- Possible Runoff Election on September 23, 2025

Chair Allen discussed that the DRE was proposing changing the AV location from two to one for the upcoming Special Election, but the DRE has since rescinded that proposal.

Director Williams responded by saying after hearing from stakeholders and the county manager the DRE has decided to keep both locations for the upcoming election. This Election was not scheduled on the SOS election calendar for 2025; this is a special election called by the Governor that the DRE does not have funds allocated. **Madam Director** mentioned that the DRE is still reviewing their current budget to identify funds but, if necessary, the DRE will request additional funds from the Board of Commissioners (BOC).

EXECUTIVE SESSION

Chair Allen entertained a motion to close the regular session and convene into executive session to discuss litigation matters. The motion was made by **Mrs. Crawford**, seconded by **Mr. Heekin** and carried by a unanimous vote of 5-0.

After the executive session, **Chair Allen** entertained a motion to reconvene from the executive session. The motion was made by **Mrs. Crawford**, seconded by **Mr. Selby** and carried by a unanimous vote of 5-0.

OLD BUSINESS

#6- CONSIDERATION OF PROPOSED CANVASSING POLICY

- Bi-Partisan Canvassing Policy
- Board Member Heekin's Policy

Mrs. Crawford suggested that the BRE craft a new policy that aligns with recent rulings by the Supreme Court.

Mr. Heekin suggested that the BRE hears from **Attorney Alexis** on his recommendation regarding the policy presented for consideration.

Attorney Alexis recommended reworking the policy for conformity.

Ms. Adams made a motion to table the Canvassing Policy; however, the motion failed for lack of a second.

Chair Allen entertained a motion to reconsider the Canvassing Policy after counsel review. The motion was made by **Mrs. Crawford**, seconded by **Mr. Heekin**, and carried by a unanimous vote of 5-0.

ADJOURNMENT

There being no further business, **Chair Allen** entertained a motion to adjourn. **Mr. Selby** moved to adjourn the meeting, **Mrs. Crawford** seconded the motion. There being no further business on the agenda, the Board adjourned the meeting at 12:10 p.m.
