# **Director Williams** updated the BRE and the public:

- Senate District 21:
  - District 21 spans portions of Cherokee and Fulton counties
  - Fulton County section includes the City of Milton and parts of Alpharetta and Roswell
- 12 Polling locations assigned
- 2 Advance Voting locations
- 1Drop box
- 6,709K+ Cast Ballots during Advance Voting
- 4.7K+ Cast Ballots on Election Day (as of 6pm)
- 60 Cast Absentee Ballots
- 20% turnout, Runoff turnout was higher

**Ms. Adams** asked about poll workers that are no longer assigned to polling locations

**Director Williams** responded that the polling location changes were presented to the BRE for various reasons (renovations, conflict of schedule, denial). Madam Director said that there is a surplus of poll workers that are not assigned but those workers are given priority for placement. She mentioned the DRE's analysis on the preferred method of voting (early voting) and actively attempting to save cost.

**Ms. Adams** asked about the outstanding Absentee ballots (21).

**Chief Glenn** responded yes, 21 ballots are outstanding including the ballot at one of the satellite offices.
