Chair Allen announced the additional meetings due to the additional elections. Madam Chair suggested combining some meetings, if possible.

Mrs. Crawford agreed with potentially combining some meetings especially around the holidays and she asked will all the documents be available.

Director Williams suggested having the meeting later in the day in case there are Provisionals that have the 5pm requirement that Friday.

Ms. Adams responded that she does not want to be here during the holidays, but she explained the complexity of collecting all the data. She asked could members come in on a Thursday.

Director Williams recommended early Friday, per the Canvassing Policy.

Chair Allen entertained a motion to approve the amended BRE Schedule. The motion was made by **Mrs. Crawford**, seconded by **Ms. Adams**, and carried by a unanimous vote of 4-0.

#4-OVERVIEW OF EMERGENCY POLLING PLACE CHANGES

Director Williams explained that the changes were due to scheduling conflicts, renovations, and community complaints; all changes have been advertised and all electors will receive an updated precinct card. She added that 4x4 signs will be placed at all locations of the changes.

Ms. Adams expressed concerns of sufficient notice to the voters. She mentioned complaints she received during the last election.

Mr. Selby asked are their other ways to reach voters (robocalls, text, etc.).

Director Williams explained that the DRE has explored that previously, the challenge is voters must **OPT IN**, but she will revisit that suggestion to see what is permissible.

The BRE requested that External Affairs be heavily involved in ensuring all outlets are updated and informing the voters.
