#1- APPROVAL OF AGENDA

Chair Allen suggested postponing discussions on item #5 due to recent rulings by the Georgia Supreme Court that may impact the proposed Canvassing policy.

Hand Count Rule:

The court affirmed a lower court's decision to permanently block a rule requiring hand counting of ballots, a process that had faced criticism for potential issues like ballot spoliation and voter disenfranchisement.

State Elections Board Rules:
The court struck down several anti-voting rules enacted by the State Elections Board, ruling that the board had overstepped its authority.

Chair Allen asked **Attorney Alexis** should we continue to Certify the Elections based on previous practice.

Ms. Adams suggested the BRE discuss the recent decision by the Courts pertaining to election matters.

Attorney Alexis agreed that the DRE should continue to proceed in the same manner and the office will fully review and opine during the July meeting.

Chair Allen entertained a motion to approve the agenda as amended. The motion was made by Mr. Heekin, seconded by Mrs. Crawford, and carried by a unanimous vote of 4-0

#3- APPROVAL OF THE MINUTES

Director Williams agreed to providing hard copies as soon as possible but noted that we are conducting an election.


NEW BUSINESS

#6- APPROVAL OF AV LOCATIONS FOR THE SPECIAL ELECTION OF AUGUST 26^{TH}

Senate Seat 21

- > Alpharetta Library
- Milton Library

Governor Brian Kemp issued an executive order for a special election on Aug. 26 to replace former State Senator Brandon Beach, Republican.



Director Williams provided a brief overview of the Special election called by Governor Kemp:

- Registered voters: 70K
- Impacted voters that reside in the Alpharetta, Roswell and Milton

AV Dates and Hours:

August 4-16th Hours: 9-5pm
 August 18-22nd Hours: 9-6pm

- Saturday voting no Sundays
- Possible Runoff Election on September 23, 2025

Ms. Adams inquired about the proximity of the AV location of impacted voters.

Director Williams explained that all AV location decisions are based on data the DRE maintains per election.

Chair Allen entertained a motion to approve the proposed AV locations for the Special Election on August 26, 2025. The motion was made by **Mrs. Crawford**, seconded by **Mr. Heekin**, and carried by a unanimous vote of 4-0.

#7-BRE MEETING SCHEDULE UPDATES AND CHANGES

The **BRE** discussed the changes to the pending meetings and times.

> June: Pre-Certification and Certification Meeting Times

Ms. Adams outlined items needed to certify the election.

Chair Allen entertained a motion to approve the proposed dates and times for the Pre-Certification and Certification meeting. The motion was made by **Ms. Adams**, seconded by **Mrs. Crawford**, and carried by a unanimous vote of 4-0.

> Removal: **August 14, 2025**

The Department and members of the Board will be engaged in a statewide training in Savannah, Georgia. Georgia Association of Voter Registration and Election Officials (GAVREO) in conjunction with the Carl Vinson Institute of Government will conduct a series of training for all 159 Georgia Counties.
