Chairperson Cooney announced that this teleconferenced meeting is authorized pursuant to §50-14-1(g) of the Official Code of Georgia because of the Public Health State of Emergency declared by Governor Kemp on March 14, 2020, and renewed most recently on June 29, 2020, pursuant to which public meeting spaces in state and local Government have been closed due to COVID-19, and because means have been afforded for the public to have simultaneous access to this teleconference.

#1- APPROVAL OF AGENDA

Chairperson Cooney entertained a motion to approve the agenda. The motion was made by Mr. Wingate, seconded by Dr. Ruth and carried by a unanimous vote of 5-0.

#2- COMMUNICATIONS AND PUBLIC RESPONSE

Aileen Nakamura, Member of Coalition of Good Governance, implored the BRE and the DRE to mail every registered voter an Absentee request form. Ms. Nakamura expressed frustration with her voting experience in the last two election cycles with regards to the Absentee by Mail process. Ms. Nakamura suggested creating a position in polling locations to allow staff to collect cast Absentee ballots.

Rhonda J. Martin, Board member for Coalition of Good Governance, implored the **BRE** and **DRE** to provide an efficient portal system and providing voters with more convenient drop boxes throughout the county.

NEW BUSINESS

#3- OVERVIEW OF AUGUST 11, 2020, GENERAL PRIMARY RUNOFF ELECTION

Mr. Barron informed the Board:

102,006 Ballots cast
 33,077 Votes cast during Early Voting
 36,236 Absentee by Mail (ABM) counted

38,278 Votes cast on Election Day, according to Non-partisan race

781 Provisional Ballots cast
1,004 Total Rejected Ballots
474 No Signature Ballots
530 Untimely Receipt

Mr. Barron mentioned that no other information has changed from the last two meeting**s** held but he can take questions on the information presented.

4- CERTIFICATION OF ELECTION RESULTS: AUGUST 11, 2020, GENERAL PRIMARY, NONPARTISAN ELECTION AND SPECIAL RUNOFF ELECTION

Chairperson Cooney asked **Mr. Barron** was it his certification and testimony that the election results presented are a true and accurate count of all the votes cast in the General Primary Runoff Election held on August 11, 2020.

- Democratic Primary Runoff Election, August 11, 2020
- Nonpartisan Primary Runoff Election, August 11, 2020

Mr. Barron answered yes

Chairperson Cooney entertained a motion to certify the election results. The motion was made by Mr. Wingate, seconded by Mr. Johnson and carried by a vote of 4-0-1, Ms. Nuriddin abstained.

#5- APPROVAL OF EARLY VOTING LOCATIONS FOR SEPTEMBER 29^{TH} , SPECIAL ELECTION

Chairperson Cooney announced this Special Election is called to fill the unexpired term of the 5th Congressional District.

Mr. Barron discussed the locations to approve:

- Buckhead Library
- > C.T. Martin Natatorium and Recreation Center
- College Park Library

- Metropolitan Library
- Northwest Branch @ Scotts Crossing Library
- Ponce De Leon Library

Mr. Johnson inquired about adequate coverage throughout 5th Congressional

Mr. Barron asked Ms. Benjamin about locations in 5th Congressional

Chairperson Cooney inquired about voter turnout

Mr. Barron asked Mr. Jones how many ballots he has mailed, to provide the BRE with an estimate turnout

Dr. Ruth asked about the reason for not utilizing Chastain Recreation Park

Mr. Barron answered that the Fulton County IT Department does not recommend using this location due to security concerns

Mr. Johnson inquired about other locations to utilize for this Special Election, most notably the Evelyn Lowery at Cascade Library

Mr. Barron directed Ms. Benjamin to review the availability of the Cascade Library

Ms. Nuriddin asked Mr. Barron about his rationale for the six EV locations for this Special Election

Mr. Barron stated voter turnout and limited funds were determining factors for the EV location

Chairperson Cooney inquired about using the colleges as outreach

Mr. Barron stated that changes can be made

Mr. Wingate inquired about the number of registered voters assigned to the 5th Congressional District

Mr. Jones informed the board **that** the number of registered voters in 5th Congressional District **is** 386,733

Mr. Wingate inquired about the political party affiliation of the candidates

DRE informed the Board, the seven candidates' party affiliation for the upcoming race of the 5th Congressional District:

- 5 Democratic
- 1 Independent
- 1 Libertarian

Ms. Nuriddin asked about the turnout between CT Martin and State Farm

Ms. Benjamin mentioned CT Martin exceeded State Farm

Chairperson Cooney entertained a motion to approve the six Early Voting locations for the September 29th Election. The motion was made by Ms. Nuriddin, seconded by Dr. Ruth and carried by a unanimous vote of 5-0.

#6- APPROVAL OF POLLING PLACE CHANGES: 51/2020 THROUGH 65/2020

Ms. Williams explained the precinct proposals. All polling locations are American with Disabilities Act (**ADA**) compliant and all impacted voters will be notified 30 days prior to the next scheduled election.

Mr. Barron responded **that** at the conclusion of the meeting **voters in 62/2020** will be mailed a Head of Household **letter** (**HOH**) immediately due to the emergency move; all others will be mailed a **HOH** on September 29th Election

Chairperson Cooney entertained a motion to approve the Polling Place changes for the upcoming General Election and one emergency Change for September 29th Special Election. The motion was made Mr. Johnson, seconded by Ms. Nuriddin and carried by a unanimous vote of 5-0.

Ms. Benjamin updated the Board that Evelyn Lowery at Cascade Library is located in Congressional District 5 and is available to be an Early Voting Location for the Special Election for the 5th Congressional District on September 29th

A motion was made to approve an additional Early Voting locations for the September 29th Election, Evelyn Lowery Library at Cascade added. The motion was made by Mr. Wingate, seconded by Ms. Nuriddin and carried by a unanimous vote of 5-0.
