Chairperson Cooney announced that this teleconferenced meeting is authorized pursuant to §50-14-1(g) of the Official Code of Georgia because of the Public Health State of Emergency declared by Governor Kemp on March 14, 2020, and renewed most recently through September 10, 2020, pursuant to which public meeting spaces in state and local Government have been closed due to COVID-19, and because means have been afforded for the public to have simultaneous access to this teleconference.

#### #1- APPROVAL OF AGENDA

<u>Chairperson Cooney entertained a motion to approve the agenda. The motion was made by Mr. Johnson, seconded by Mr. Wingate and carried by a unanimous vote of 4-0.</u>

#### #2- COMMUNICATIONS AND PUBLIC RESPONSE

**Cynthia Battles** (Common Cause Georgia) urged the **BRE and DRE** to adopt the recommendation presented by their partners at Brennan Law regarding providing all polling locations with adequate supplies and at least 40% emergency/ provisional ballots

**Gowri Ramachandran** (Brennan Law) urged the **BRE** and **DRE** adopt the recommendation presented to this Body. **Ms. Ramachandran** implored the **BRE** to provide 40% emergency/ provisional ballots instead of the state mandated 10% due to the record number of expected turnout of voters this upcoming election and to ensure voters are not disenfranchised

#### **NEW BUSINESS**

## #3- DISCUSSION OF SEPTEMBER 29TH, 2020, SPECIAL ELECTION FOR CONGRESSIONAL DISTRICT

**Mr. Barron** informed the Board of two **incidents** that occurred at the two polling location this morning. **Poll workers at** Ponce De Leon Library could not gain entry to the building due to issues with the key.

One voter voted outside- emergency ballot was issued

Park Tayern the security guard did not show on time

Six voters voted outside- emergency ballots were issued

Therefore, all polling locations opened on time and there was no delay in the voting process

**Mr. Barron** mentioned an issue at a polling **place** with one of the carriers containing voting equipment and the technician onsite was unable to resolve.

Mr. Barron informed the Board:

94 Polling Locations

8,756 Votes cast during Early Voting

450 Absentee by Mail (ABM) counted; Drop box ballots count remaining

11,855 Votes cast on Election Day as of 5:00 p.m. on Election Day

105 Provisional Ballots as of 5:00 p.m. on Election Day

**Mr. Barron** explained the process of moving voters while conducting an election where some voters were affected. **Mr. Barron** contacted Secretary of State (**SOS**) office about the ability to move voters according to the election. The State's database system, ElectioNet, is unable at this time to delineate between the elections. Therefore, the **DRE** was required to move all the voters into their new polling locations, order **their** precinct cards and mail their **HOH** mailers to ensure clarity. Once that task was completed the **DRE** was tasked with returning all the voters in the 5<sup>th</sup> Congressional District back into their previously assigned precinct for the Special Election. The error was made when a letter was mailed to voters in the 13<sup>th</sup> District **of whom** approximately twelve voters **appeared** at that location.

**Dr. Ruth** inquired on the timeframe of the resolution regarding the BMDs

**Mr. Barron** informed the **BRE** there were six BMDS assigned and four were operational, no disruption to voting. A roving technician from the Election Preparation Center (**EPC**) was able to quickly resolve due to close proximity of the poll

Chairperson Cooney reiterated the preliminary statistics listed above

Mr. Barron mentioned Chairman Pitts and County Manager Dick Anderson visited several polling locations, they both reported low turnout

- Mr. Wingate inquired about the conclusion of the election tonight
- Mr. Barron answered that runners are on standby and he hopes to complete by 11pm, when the news is on
- **Mr. Barron** mentioned some inquiries received today from **BRE** members regarding the 39<sup>th</sup> Senate District Race on the ballot on November 3<sup>rd</sup>. **Mr. Barron** mentioned he contacted the **SOS** about this race:
- If you request an ABM 39<sup>th</sup> Senate Race will be on your ballot
- If you vote in person you can choose a ballot with or without the Senate race
- **Mr. Barron** noted that it seems unfair that a voter would have to indicate their party of choice during a General Election. **Mr. Barron** stated according to **SOS** personnel this procedure is in accordance with the code.
- Mr. Wingate asked was this issue discovered during L&A Testing
- **Mr. Barron** stated no, this was discovered during training when the **DRE** was training poll workers assigned to polls in that district.
- Mr. Barron reported that during pre-election testing on the new BMDs, election officials in two counties discovered a problem with the display for the, 21-candidate U.S. Senate race. Under certain circumstances, not all of the candidates' names would not fit on a single screen. Mr. Barron stated that the candidate display issue was discovered by another county with regards to the Senate Race with twenty candidates
- Chairperson Cooney asked did this delay the DRE's L&A Testing
- **Mr. Barron** stated no, the **DRE** was not scheduled to begin L&A Testing until October 1<sup>st</sup> due to this Special Election for the 5<sup>th</sup> Congressional District unexpired term
- Mr. Johnson asked for clarity on District 39 Senate Race
- **Mr. Barron** clarified his inquiry with **SOS** about the race. **Mr. Barron** intend to contact SOS to provide a better understanding of the Senate District race
- **Ms.** Nuriddin urged and encouraged voters to vote in the Senate Race. **Ms.** Nuriddin informed the body that she was informed by Director Harvey of **SOS**; District 39 Senate is a Democratic Special Primary. **Ms.** Nuriddin noted that during a General Election voters are not required to declare a party
- Mr. Wingate noted the turnout seemed very low
- Mr. Barron explained that no Rollover Ballots were mailed for this Special Election
- Mr. Johnson mentioned there being confusion surrounding this election with regards to the Rollover Ballot List
- Mr. Barron agreed and noted that this will be the case during the Special Runoff Election in December

Chairperson Cooney mentioned action should be taken by the Board and notifying the voters simultaneously

**Mr. Barron** noted that the Election Codes provides exceptions to Rollover Ballots being mailed and during a Special Election; this is one of the exceptions

#### **#4-DISCUSSION ON PREPARATION OF THE GENERAL ELECTION**

**Mr. Barron** informed the **BRE** that today approximately 35 Poll managers assigned to work during the General Election shadowed experienced Poll Managers

#### Mr. Barron discussed:

- Allocations Completed- BMDs, Poll Pads, & Scanners
- Mobile Schedule- Pending
  - o 3 Check-in
  - o 10 Voting Stations
  - o 1 scanner
  - ADA Compliant
- Training will resume this week
- Know Ink committed to ensuring efficiency
  - Cachebox Testing
  - Providing support throughout the November Election
- Reservation at Dominion Warehouse- back-up to ensure poll pad bulk file upload is efficient

**Mr. Barron** discussed the county's portal streamlining the **processing** to be able to process request from two **locations** due to the ability to scan all **requests** into the County's portal: SOS Portal and DRE's Portal

- 30 EV Locations:

- 18 Days of Mobile Voting, last Day will operate as the overflow for the busiest EV locations

- ABM Ballots have been mailed
- SOS has Ballot Tracks for voters with inquiries

#### Mr. Wingate inquired about the final mobile schedule

**Ms. Williams** responded that **a** few locations are pending, upon approval from those facilities. Ms. Williams anticipates completion in the upcoming days

- Dr. Ruth inquired about the testing Know Ink is conducting with the Cachebox
- Mr. Barron stated yes, Know Ink was onsite yesterday testing the Cachebox and testing continued today.
- **Dr. Ruth** expressed concerns regarding timeframe remaining and limited resolution. **Dr. Ruth** asked how soon the bulk file can be uploaded for Election Day
- Mr. Barron explained that uploading begins early that Saturday morning, the day after early voting ends. Mr. Barron mentioned being in close contact with the President of Know Ink and he believes a

solution will be found, there have been some improvements in the past few weeks. Final Step, **Mr. Barron** noted will be to install the Meraki devices and complete final testing

**Dr. Ruth** expressed approval of the working relationship that was formed between Know Ink and the **DRE** in recent weeks. **Dr. Ruth** asked will Know Ink support the **DRE** during EV and Election Day

**Mr. Barron** explained the Poll Pads are used differently during EV and on Election Day, EV use the poll pad as a card creator and there have been limited issues with the exception **of** the last election at those four EV locations. **Mr. Barron** noted that the county just **purchased** Cradle Points for each polling locations, the **DRE** currently **has** three Cradle Points. This will enable the **DRE** to see the status of equipment in polling **locations** and reset the poll pads, if needed.

Dr. Ruth inquired about the allocation of Emergency/ Provisional ballots

**Mr. Barron** explained the law states 10% required; however, **DRE** intends to provide 20% possibly because 10% is inadequate

**Dr. Ruth** directed to be updated when the percentage is finalized

#### **#5-CONFIRMATION OF CERTIFICATION DATE**

**Mr. Barron** suggested conducting the Certification of Results for the Special Election to fill the unexpired term of the 5<sup>th</sup> Congressional District on the same day as the Regular Meeting, October 8<sup>th</sup>, Thursday

#### **EXECUTIVE SESSION**

<u>Chairperson Cooney entertained a motion to close the regular session and convene into executive session to discuss pending litigation. The motion was made by Mr. Wingate, seconded by Mr. Johnson and carried by a unanimous vote of 5-0.</u>

After executive session, Chairperson Cooney entertained a motion to resume into regular session.

The motion was made by Ms. Nuriddin, seconded by Mr. Wingate and carried by a unanimous vote of 4-0.

#### **ADJOURNMENT**

With no other items requiring the Board's action, <u>Chairperson Cooney entertained a motion to adjourn.</u>

Mr. Johnson moved to adjourn the meeting. Ms. Nuriddin seconded the motion. Collectively, the Board agreed to adjourn at 8:08 p.m.
