#2- COMMUNICATIONS AND PUBLIC RESPONSE

Diane Chauffe:

It's critical that the Fulton County boy the nation's remains in control of our local elections. We should not and cannot have the state legislature takeover when they don't like the election outcome. I commend the board for work that has been done and providing us with early voting options. However, the blatant voter suppression laws of SB 202 is unconscionable. It limits the ability of the board to provide voter access. That is, the Fulton County can only have eight ballot drop boxes, we had 38. And the drop boxes are only

available indoors at early voting locations, and only available from 9am to 6pm. And only October 12- October 29. That Drop boxes we're available 24 hours a day, seven days a week with continual video surveillance. And they were available until 7pm. Election Day. **Angie Thomas**

Coleen Boyle

I have a history in the county of 36 years as a voter voting the same precinct. Also, because of my concerns about election related issues, I served as a poll worker and the 2020 election at a different precinct and then the one I voted as the voter I felt the county provided consistent and transparent services comparable to those of my work colleagues and surrounding counties of Cobb, Gwinnett, and Fayette counties. As a poll worker and the November 2020 election, I was impressed by the rigor of the election process and the oversight provided by the county and the quality and the integrity of those at my specific precinct in terms of facilitating the process. At the poll site, I also to better understand the process of volunteer to run the paper that paper ballots at the end of the day and experienced a similar organized and transparent process. So in summary, both my experience as a voter as well as my experience as a poll worker, were positive.

Kim Goldsmith

I have been a Fulton County voter for nearly 50 years. And I want to commend the Fulton County Board of Elections for its history and current support of early voting and voting rights. This is a scary time around voter suppression. A lot of people didn't like the results of the elections. They talked about the drop boxes, but the hours have changed, voting by mail is more difficult, obviously, tactics to suppress each person's vote, and nothing about gerrymandering. So I commend what Fulton County does to try and protect each person's right.

Susan Voyles

I'm a resident of Sandy Springs in Fulton County. And I am aware that you have been emailed a packet by a group of people that asked me to speak today, and this presentation reflects a considerable amount of work by a group of small private citizens. These are the facts and data that Fulton County Elections provided with appropriate chain of custody. And you all are responsible for the safety and security of elections here in Fulton County. Therefore, at a very minimum, we know there is enough evidence presented in the packet that you have to warrant further investigation by you.

Micah Wedemeyer

You may recognize this mask. This is my official Fulton County Poll Worker mask that I was given when I sign up. I became a poll worker after the difficulties of the June primary. I'm very proud of the work that we did as poll workers in 2020 and 2021 provided safe efficient elections for Georgia voters. And I even volunteered to be a manager and I'll be managing my precinct in November. And all that is to say why I'm incredibly saddened and frustrated by Senate Bill 202. And everything that comes with that and the continuing hostility towards Fulton voters. We poll workers we did a good job under difficult conditions. And all that we've been rewarded with is from the state legislature suspicion and furthering of the big lie that we participated in a massive conspiracy to defraud Georgia voters. With a cynical partisan maneuvering. The state legislature has shown it is unfit to manage the responsibility of Fulton elections, which

is why the Fulton County Board of Elections last remaining control a state takeover put election controls in the hands of those who have shown zero interest in supporting our hard work of running fair efficient elections. And instead of simply use it as an opportunity to further disenfranchised voters. Please continue to support us, the frontline, frontline poll workers so that we can continue to support Fulton voters.

Milia Akkouris

I echo the sentiments of the previous gentleman as a poll manager. My election integrity journey began here in 2018. Some of you may remember that's when I made my first public comment ever. I've since worked several elections, and that serve as poll manager proudly. First, let me start with some positives. I'm very excited and optimistic about some of the process improvements I heard about yesterday during poll manager's training. I'd like to give a shout out and a accommodation to Alexandria Royale, my Regional Coordinator, she's been phenomenal to work with specifically about some process improvements, I'd like to call out the binder that was created, Johnny Harris and his team made a binder of all the documents and I think that'll really help in the back of the house. And also the idea of putting multiple drop off locations. For poor managers, I think that'll really help with the process. As long as those in charge of these pulling drop off locations, precinct drop offs, are well knowledgeable about the process in place. However, I'm disheartened about SB 202 specifically over the fact that we can't provide provision (water) for those who may be experiencing medical related distress as a first responder flight attendant. I have issue with that. Also, with the eight drop off locations, others have mentioned that I'd like to go a step further. I vote early all the time, because of my co-worker responsibilities. Last year I walked and this year I actually mapped all of the locations, if I had to take public transportations would take me at least 40 minutes to get to a drop off location. And then if I do shift work, I might need to decide between being fired and voting. Also, based on my experience, often precinct information is not correct. I don't know who's at fault there if it's Fulton County, with the state, but denying voters who vote out of precinct before 5pm Or not counting their vote regardless of circumstances, but to suppress it burden on the voter, for any error made by either Fulton County or the Secretary of State.

Mr. Johnson inquired about the E-SPLOST AND T-SPOLOST in the City of Palmetto and Mountain Park

Mr. Barron explained that there are signs up but voters in Palmetto have to go to two different locations to vote. They want to vote on the county, E-SPLOST AND T-SPLOST, they go to the library and to vote for city race voters are directed to City Hall

Mr. Johnson inquired about the United States Post Offices having a structured slow down on the mail. Now for mine, it's primarily male that's going from state to state or going long distances in told that it shouldn't be a problem for local municipalities

- Mr. Barron directed Ms. Bodison to contact the DRE's liaison from the U.S.P.S
- Mr. Johnson inquired about concerns city of Fairburn had
- Mr. Barron explained that the DRE spoke with Mayor Hurst and everything was resolved.
- Mr. Wingate inquired about to mock elections in the month of September
- **Mr. Barron** explained that EV personnel met to go through the process and the EPC's personnel tested the WDS System (inventory system) utilizing the scanners
- Mr. Wingate inquired about borrowing equipment from Gwinnet County
- **Mr. Eskridge** responded that it was to ensure the elections had adequate equipment. Gwinnett's Board voted no on this matter.

Mr. Wingate asked about the drop boxes and do they require security cameras 24/7 under SB 202.

Mr. Barron responded that the DRE have a person that is monitoring the drop, because they've been moved inside the polling places

Ms. Williams added that the libraries that the County currently utilize for Advance Voting, we actually have cameras in those rooms, as part of the building itself. But no cameras were installed for the purposes of surveilling the drop boxes.

Mr. Wingate asked do DRE have any concerns that there could be a security breach, even though supposedly they're securely in a position where they shouldn't be tampered with, or somebody can stick whatever in them, if they're unattended on a 24/7 basis.

Mr. Barron mentioned that the drop boxes are emptied at the end of the day, and then they're inaccessible until the next morning.

Mr. Wingate inquired about the Chain of Custody

Mr. Barron answered documentation is completed daily.

Mr. Wingate inquired about the amount of ballots that have been mailed.

Ms. Bodison responded 4,508

Mr. Wingate inquired about the roll over list

Mr. Barron responded that before the DRE would mail out applications to any voter 65 and older or disabled, we are not allowed to mail those out anymore. SB 202 prohibited this action.

Mr. Wingate asked about the Sandy Springs' ballot error

Mr. Barron explained that the error was only on the composite ballot completed internally not on the ballot voters are casting. **Mr.** Barron noted the old Election Management System would create a composite ballot, so that every city would be on one ballot but the new system does not.

Madam Chair inquired about the August and September voter registration applications and why the numbers were down

Mr. Barron responded, this change was noticed in March. It's dropped significantly this entire year. So I think it used to be the DDS was an opt-in, you had to actually physically put on there that you wanted to register to vote. Then when the Governor was the Secretary of State, I think he and DDS worked something out so that it was an opt-out. So all voters that went to DDS generated an application. Now, something has changed significantly so that we are getting an application for every single person that goes into DDS, but we've never been informed.

Dr. Ruth inquired about Alpharetta Library and Newtown opening late

Mr. Barron responded that the power outage concerns were prior to the EV locations were scheduled to open.

- **Ms.** Benjamin responded that no location opened late because each location had a system Specialist on duty. And when Alpharetta lost power the manager confirmed, we had four units at 90% in battery, and we had two units 100%.
- **Dr. Ruth** mentioned concerns she heard from Poll workers experiencing a few challenges with Happy Faces (**HF**) in the onboarding process, it's not a streamlined process. And so I just wanted to see if you're hearing that issues around that Sharon
- **Ms.** Benjamin responded that staff had some issues with onboarding and understanding the process. So those individuals were directed to Happy Faces to go through their procedures.
- Ms. Crawford asked when did the Absentee Division received their supplies from the SOS.
- Ms. Bodison answered on October 8th; although, they were promised weeks prior
- **Mr. Barron** added that the DRE received them so late that we weren't able to work with the vendor to get a barcode onto them. And so we are stuffing them by hand, rather than using our Bluecrest machine that does everything for you.
 - **Mr. Wingate** asked during the cycle, how many Dominion employees our oon board? How many Happy Faces' personnel? How may Knowlnk personnel?

<u>Chairwoman Woolard entertained a motion to adopt agenda. The motion was made by Ms. Crawford, seconded by Dr. Ruth and carried by a unanimous vote of 4-0.</u>

#2- RESIDENCY CHALLENGE HEARING AGAINST VOTERS REGISTERED IN FULTON COUNTY

Madam Chair announced the reason for this Special Called Meeting:

A residency challenges against a number of voters registered in Fulton County. According to the law, we've notified people appropriately within the designated time and we're holding the meeting within the 10 day window from the notification of the challenge. Madam Chair asked if Ms. Pauline Cup and Mr. Samuel Ambrose are here for the challenge.

Mr. Barron announced that challengers were not present and both rescinded their challenges.

Chairwoman Woolard responded the BRE will proceed with the hearing and make our own determination as you all know, the burden of proving the challenge falls on the challengers so to initiate this process and not show up for the Special Called Meeting to me is an indication that we can move forward in dismissing this or whatever action the board might care to take. And I'm open for comment at this point.

According to the law, I am not a lawyer, so please correct me. Once we've made whatever determination we choose to make if they disagree with our determination, they can appeal that decision in superior court. I don't know if the law addresses whether they're able to come back with the same list and re-challenged. I would think that they would have to challenge our determination first, right. That's when they would have to go to court to challenge our decision on each and every one of these that they would care to bring back. And then whatever the court says we do is we would handle it

Mr. Johnson asked the process for citizen or voter. What's the process to begin to be able to even challenge someone?

Mr. Barron replied anyone can challenge a voter, with no reasoning or limitation in number Revision to Code Section 21-2-229
Revision to Code Section 21-2-230

Attorney Ringer responded that the challenger is relying on the NCOA

Mr. Johnson ask what is NCOA?

Attorney Ringer responded National Change of Address

Mr. Johnson asked if that was something the Secretary of State (SOS) uses

Attorney Ringer responded yes and will allow Ms. Smith to expound

Ms. Smith added:

Pursuant to 21-2-233. The National change of address process is a process the Secretary of State's office is allowed to do what they take the official list of electors, and they compare it to the United States Post Office change of address. And that process actually ran back in 2020. And it's a process like I said they compare the electors addresses if it is change. If it appears that the address has changed, have an elector who has moved to a different address within the county that they are presently registered. The list of electors shall be changed to reflect the new address and the electors shall be sent notice of the change by forwardable mail to their old address. If it appears that the Elector has moved outside of the county where they are presently registered, they will receive a confirmation notice and that's the confirmation notices that were sent out was a huge chunk back in December 2020. They receive a confirmation notice to the old address.

Mr. Johnson asked do the challengers are using a list that the Secretary of State's office is already using in order to check addresses and to update voter's status

Ms. Smith answered the VR Division went through the list to see exactly what the voter's status was and about half of the voter's statuses were already in either inactive NCOA or an inactive no contact type of status, but the majority of them are inactive NGOs.

Dr. Ruth asked so a number of the voters that were a part of this challenger's list? I think, Mr. Johnson brings up a good point that this is something that will probably be reoccurring, and it's incumbent on us to cross check those challenges with what the Secretary of State list. Mrs. Ringer is it possible to make that known to the challenger?

Attorney Ringer responded the challenger is already aware because their getting a list from SOS

Mr. Barron mentioned another mechanism for ensuring voter's roll are as accurate as possible. Electronic Registration Information Center (**ERIC**) utilized by 29 states plus Washington DC

Mr. Barron stated, I don't think we can be positive on these lists by what is matched because we don't have for example, the last four digits of the social security number or any sort of birth date or anything like that, to match against the person that is in another state. The DRE have the names and no identifying information to really make a determination

100% elimination on anybody that's where I would be hesitant to remove someone unless we had more information. When voters are removed there are multiple layers they can match a person against and in this case we aren't getting that luxury to make our determination.

Attorney Ringer provided clarity, the list in front of the board. It's not a list that your staff created. This is what the challenger sent to the DRE.

Mr. Barron responded yes.

Attorney Ringer added that the DRE have an issue with trying to verify what the challenger sent.

Mrs. Crawford asked do we normally get lists like this that are done by House districts?

Chairwoman Woolard emphasized for the public that might be watching that the burden is on the challenger. To prove to us that there is a problem with the voters. It is not up to us to go find birthdates, track people down, and do all that they have to bring us the evidence that makes it clear that there's something we can do beyond what the Secretary of State's already set into motion.

Mr. Johnson shared a scenario that could jeopardize an elector and their right to vote with the information the challenger provided when multiple electors have similar information as someone in a different state.

Madam Chair

One of the things just given my background that I've been looking at is a lot of new law, most of which is untested in terms of its actual functionality, and that at some point, we should be working with other counties to bring forward process improvements because just so people know once we get the notification and it can come under the transom over the transom through the front door; however, it comes at that moment that starts the 10 days from which we have to have a hearing. Only make it really clear how much I appreciate the staff. You all are great you are in the process of trying to run an election in many jurisdictions, right on top of having to stop and do these things. On top of that, we're all volunteers. We all have jobs. We all have families and other responsibilities. I've been on this board for a month. This is my second special called meeting I doubt it'll be my last one for the month. And I don't mind doing the duty but I do mind. Having to listen to things that are not fully baked and receive notification in the middle of the night from the challengers that they don't want to come down. Well, that's not on them. They've now started the clock and we are now responding to that. So again, I want to thank the staff and I want to thank you all members of the board because we all had to mobilize very quickly we are meeting in this room. because one of the challenges we had was to find a room where we could be videotaped and everything so that we could do what we needed to do to fulfill our part of the law and the other room isn't available to us. So it is not easy to thread the needle on the 10 day clock on top of making the notification once we could figure out where we could even hold the meeting in that time frame. So all that is to say one things I would ask the staff to do is to work with us to think about very specific process improvements. In my mind these challenges should start with the Secretary of State's office. They should be wonderful if the secretary of state determines that all of these people are already on the list, and everybody's cognizant of where they are and the clock is started on that. Then me that's where the buck should stop for every county and then anything else that needs to flow through as a challenge that isn't currently being addressed through the Secretary of State's process will become something that we need to take action on. This is putting a burden on us. Right? There's not a burden on the challenge or this is a burden on us and it's time and money spent with our staff to try to get this done. So I'm I am hopeful that we will continue to be mindful of that and it is my goal by the next session to you know, to have a list, even if it's one or two things that we can continue to put forward. That will help us make this a smoother process or otherwise we'll get around to the federal elections. Next year in particular and when you see these challenges come forward, it will make it very difficult to run elections as smoothly as our intent.

Mr. Barron mentioned in the future there could be multiple 10 day clocks.

Again, to me the solution is it starts in the Secretary of State's office gets resolved if people are already on a list for removal or being inactive then if that is a legitimate challenge that needs to come forward that has all of the required documentation that would let us make a decision. You know, you said you know a birth date a social security number, some other indication because regardless if somebody sends us a list like this, the determination will always be the same. We don't have the information we need to be able to reach out to remove somebody reliably from the list. So it's almost a failure completely.

<u>Chairwoman Woolard entertained a motion to deny Ms. Pauline's Cupp's challenge. The motion was made by Mr. Johnson, seconded by Mrs. Crawford and carried by a unanimous vote of 4-0.</u>

<u>Chairwoman Woolard entertained a motion to reject Mr. Ambrose's challenge. The motion was made by Mrs. Crawford, seconded by Mr. Johnson and carried by a unanimous vote of 4-0.</u>

<u>ADJOURNMENT</u>

With no other items requiring the Board's action, <u>Madam Chair Ruth entertained a motion to adjourn.</u> <u>Mr. Johnson moved to adjourn the meeting. Mrs. Crawford seconded the motion.</u> Collectively, the Board agreed to adjourn at 9:29 a.m.

ELECTIONS DIVISION

During the month of October / November the focus of the Election Division activities were on the following tasks:

November 2, 2021 General / Municipal Election:

November 2, 2021 Election was conducted with 257 polling locations 396 precincts. 91,246 (unofficial count) voters cast their ballots on Election Day. Election certification is scheduled on Monday, November 8th. An after action plan is being drafted in an effort to identify problems and improvements to be implemented next election. Preparation for the November 30th Runoff Election has commenced.

Supplies & Logistics:

Equipment pickup will continue until Tuesday, November 9th. Limitations on available truck rentals and couriers may extend the completion date. Staff is currently completing post-election supply sorting, inventory, and reconciliation.

Polling Locations:

Currently there are no polling locations anticipated for the November 30th Runoff Election. The municipalities will advise by Friday, November 5th, per unofficial election results, which contest will require a runoff which will determine the polling sites to be utilized.

Election Night Check-In Locations:

All nine check in locations were utilized for the November 2nd election. No major problems were reported regarding check in. A post-election zoom meeting will be held on Wednesday, November 10th with the check in managers and assistant managers to discuss any reported/unreported problems and to obtain their suggestions on improvements and/or enhancements.

Advance Voting:

74,969 voters (unofficial number) cast their ballots during Advance Voting. An after action plan is being drafted in an effort to identify problems and improvements to be implemented next election. The advance voting sites, dates, and hours to be utilized for the runoff election will be presented to the board on Monday, November 8th for review and approval.

Absentee Ballot Drop Boxes:

2016 voters (unofficial count) utilized the 8 drop boxes. Absentee Ballot Drop Box locations will be presented to the board on Monday, November 8th for review and approval.

Poll Worker Recruitment & Training:

Regional Coordinators are currently processing payroll for the November 2nd election. An after action plan is being drafted in an effort to identify problems and improvements to be implemented next election. Recruitment for the runoff election has commenced.

Election Preparation Center & Hapeville Annex:

L&A for the upcoming runoff Election will commence on Thursday, November 11th. Per election code requirement, an advertisement will be placed in the AJC and will be posted on the Fulton County website.

REGISTRATION DIVISION

This Monthly Report provides a summary of the critical registration activities, workload levels, and voter registration statistics for the Registration Division of the Fulton County Registration & Elections Department for October 2021. The primary activities the VR staff worked on in October were processing voter registration applications, confirmation notices, researching street issues, municipal street audits, processing registration issues, preparing notices to voter registration applicants, scanning, indexing registration cards, and training.

VOTER REGISTRATION

The total number of voter registration applications we have received in 2021 is **83,680**. We received **11,349** voter applications in October. This number includes voter registration applications received via the Department of Driver Services, the Online Voter Registration portal with the Secretary of State's Office, applications from 3rd party vendors, and applications mailed or dropped off at our office.

As of November 1, 2021, there are **847,737** (791,608 active and 56,129 inactive) registered voters residing in Fulton County.

REGISTRATION REPORTS:

CHALLENGE HEARING

On Thursday, October 21, 2021, the Fulton County Board of Registration and Elections held a challenge hearing brought about by Bruce Ambrose of Buckhead, and Pauline Capps of Alpharetta. The VR division was tasked with researching the residency status of 373 Buckhead and 189 Alpharetta voters. The challengers argued that these voters did not live at the address listed on their voter registration records. The Board denied the challenge therefore all 562 voters stayed on the voter rolls.

On Friday, October 15th, the VR division mailed letters to the voters being challenged notifying them of the challenge, and the date and time of the hearing.

On Thursday, October 28th, the VR division mailed response letters to the voters notifying them of the outcome of the hearing, and that they get to stay on the voter rolls.

FRONT DESK OPERATIONS

Our front desk personnel handles a lot of operations for the VR division. When a voter comes into the office, they fill out a yellow ticket that states their reason for visiting. Below is a breakdown of October ticket requests:

PERSONNEL/STAFFING:

We have a total of 9 permanent employees, 1 supervisor, 1 manager, and 1 chief. We have 6 Registration Officer vacancies. The position was last posted on October 27th and closed on November 1st. The management team is currently reviewing applicants to conduct interviews the week of November 8th. On Monday, October 11th we conducted interviews for the Registration Supervisor position. The job offer was extended internally to Thomas Johnson who started with an effective date of October 26th. All management positions within the VR division have been filled.

STANDARD OPERATING PROCEDURES

The Voter Registration Division completed 18 updated standard operating procedures to better streamline operations within the VR division. These SOP's will help align our department to make sure everyone is on the same page.

PETITION VERIFICATION

On October 4, 2021, the Secretary of State's Office sent a notice to all 159 counties that a recall application for Secretary Raffensperger was submitted. On October 5, 2021, we verified that the petition only had 10 valid signatures from Fulton County voters. We submitted a petition verification form to the Secretary of State's Office to ensure compliance.

The VEO Lead Trainer (Kelvin Jones) has met with the VEO Team (Cobi Haggard, Mariana McGinnis, Shantel Stephens) consistently to review voter registration, absentee applications, Senate Bill 202 updates, and the new Dominion voting equipment.

The VEO Team added a new Voter Education and Outreach Manager, LaShandra Little, and they continued to work in October to deliver services to the public. We have targeted all areas of the County: north, south, east, and west. We have conducted events with groups that we have reached out to and those seeking our assistance. We have executed events with the executive team, including Mr. Dick Anderson, and several events with the Chairman of the County Commissioners, Mr. Robb Pitts. Other notable events include multiple student engagement events with Georgia State University. We are in the early stages of planning an outreach event with U.S. Senator Raphael Warnock's office.

We are researching via ElectionNet a full voter demographic for Fulton County over the past five years to implement target areas of low voter turnout across the County to target Voter Education and Registration. We tackle this effort by separating the County into regions north, central Atlanta, and south. LaShandra Little, VEO manager, sent introductory emails to all the commissioners and External Affairs Director scheduling meetings to gain insight into VEO operations. The meeting will take place throughout November.

We are working on additional partnerships within the community. We have developed strong contacts with community stakeholders and are awaiting responses in regards to scheduling future events; also, we are in the process of setting up several new events daily. We are working to develop synergy with various groups to strengthen our impact in the community further.

We are working to make our goal of 700-1,000 touchpoints a week a reality. We are developing a Diversity Project to ensure we are being as inclusive as possible, and we are working on a major initiative with the Carter Center and Latin community. These initiatives are just a couple of projects to expand our daily scope of tasks.

We look forward to sharing those outcomes as they materialize.
