



- 8. PAINT SHALL BE NO. 3-B GREEN, BRUSHING, ROLLER, AIRLESS TYPE AND CONFORM TO GEORGIA D.O.T. ARTICLE 870.2.01 PAINT SHALL BE APPLIED TO A MINIMUM THICKNESS OF 10 MILS.
