#1- APPROVAL OF AGENDA

<u>Vice Chairwoman Ruth entertained a motion to approve the agenda. The motion was made by Mr. Johnson, seconded by Ms. Crawford, and carried a vote of 3-0.</u>

SPECIAL CALLED SESSION

#2- CERTIFICATION OF ELECTION RESULTS

Ms.Williams stated the election results for the April 5th Special Election were provided to the board which is a tabulation of absentee, advanced voting, election day inperson voting. The result will warrant a runoff election on May 3rd.

Dr. Ruth asked if the numbers provided to the board were accurrate.

Ms. Williams stated the numbers provided were the official and complete election results.

Dr. Ruth asked Ms. Williams to provide the reported information.

Ms. Williams stated the following:

- Election Day 72 votes cast
- Advanced Voting 34 votes cast
- Absentee by Mail 2 votes cast

Dr. Ruth clarified that the total was 108 votes cast.

Ms. Williams agreed in the affirmative.

Dr. Ruth asked the board if there were any questions.

Vice Chairwoman Ruth entertained a motion to certify the election results for the April 5th Special Election for House District 45. The motion was made by Ms. Crawford, seconded by Mr. Johnson, and carried a vote of 3-0.

Dr. Ruth announced the House District 45 runoff information for advanced voting and election day; confirmed the election night special meeting, and the election certification special called meeting.

Ms. Williams asked to update the election certification meeting location to the Election Preparation Center due to Grand Jury activities that week.

Dr. Ruth agreed and announced the updated location.
