ELECTIONS DIVISION

During the month of March, the focus of the Election Division activities was on the following tasks:

House District 45 Election:

The April 5th House District 45 Special Election was conducted successfully. No problems were reported during Advance Voting or on Election Day.

Supplies & Logistics - Polling Locations:

Staff is currently conducting inventory and preparing for full usage of the WDS inventory system. T-shirt distribution is being conducting during poll worker training.

Absentee Ballot Drop Boxes:

Absentee Ballot Drop Box locations have been posted on the Fulton County Website for May 24th election. Signage to provide clear guidelines regarding drop box usage are being created as an Advance Voting supply item.

Poll Worker Recruitment & Training:

Poll Worker Recruitment is actively taking place. Poll Worker Training commenced on March 7^{th.} To provide more communication with poll workers and to keep poll workers informed a newsletter is being drafted for monthly or bi-weekly distribution. Following are the recruitment totals to date:

REGISTRATION DIVISION

This Monthly Report provides a summary of the critical registration activities, workload levels, and voter registration statistics for the Registration Division of the Fulton County Registration & Elections Department for March 2022. The primary activities the VR staff worked on in March were processing voter registration applications, Redistricting, confirmation notices, researching street issues, municipal street audits, processing registration issues, preparing notices to voter registration applicants, scanning, indexing registration cards, and training.

VOTER REGISTRATION

The total number of voter registration applications we received in 2022 is **25,399**. This number includes voter registration applications received via the Department of Driver Services, the Online Voter Registration portal with the Secretary of State's Office, applications from 3rd party vendors, and applications mailed or dropped off at our office.

As of March 31, 2022, there are **840,532** (**736,764** active and **103,768** inactive) registered voters residing in Fulton County.

We have completed the Redistricting process. Awaiting one last Quality Assurance through The Secretary of State's Office new Redistricting Quality Assurance Tool (ESRI). We will use this tool to identify any final revisions that will be made in GARViS. A Redistricting manual is being prepared displaying all district changes and maps.

PERSONNEL/STAFFING

All Registration Officer positions have been filled. The Registration Manager position will be posted soon. Recruitment for Supplemental staff is ongoing with ARK Staffing Agency, the new Data Entry clerks and Front Office Specialists began on March 16th.

We are now onboarding 32 new Call Center Representatives.

CHALLENGES

On March 14th our office held a Challenge Hearing for 23 Deceased electors and 7 electors registered at Post Office Boxes. We did the research and recommended the removal of the 23 Deceased voters, the BRE approved. The 7 electors were notified by mail that their records are being challenge and they should provide a residential address for registering.

Preparation of 2022 Elections

2022 Qualifying Fees

The qualification period was scheduled for March 7-11, 2022. The Board of Commission Chair and Districts 1, 3 & 5 were the only local county offices by party on the ballot this election year. The Republican candidates qualified in our office, instead of the executive committee's office. In addition, the non-partisan offices: Magistrate Judge, State Court Judge (3 positions) and Board of Education Districts 2, 5, 6, & 7 qualified at our office,

We had one candidate to submit a notarized Affidavit of Withdrawal: Ms. Linda Arnold, candidate for Board of Education District 7

2022 Elections Budgets

The Financial Systems Manager is managing the 2022 Elections budgets and working with the Purchasing Department with contracts of four personnel agencies for our supplemental staff assigned to all three divisions.

In March, we continued to host Poll worker Recruitment Fairs across the county with a primary interest in North Fulton as there is a great need for poll workers in that region. We hosted Fairs in Alpharetta, Milton, Roswell, and Sandy Springs and will host one in Johns Creek in April. We continue to work with external affairs and have updated all of the collateral for voter education and outreach to reflect the critical 2022 election information. The VEO team hosted a great VEO Day with the Fulton County Delegation at the state capital. The event was well received and sparked positive news stories on Fox 5, 11alive, CBS, and a video on FGTV.

In March, the VEO team began outreach events within the Fulton County Schools to ensure the students eligible to participate in the May 24 election are equipped with the knowledge of how the voting process works. We hosted events at Langston Hughes High School, Banneker High School, Tri-Cities High School, North Springs, and Milton High. In April, we will continue reaching out to Fulton County and Atlanta Public Schools to set up events.

The Veo manager worked with the IT Manager and is happy to report that both mobile buses are operational and used weekly for voter education and outreach events. Also, the Voter Education and Outreach team has implemented the printing of Voter Identification Cards as an additional resource when conducting outreach events.

The VEO Manager continues to reach out to municipalities to bring voter education out to the masses at events that are already happening in the cities. In April, we will participate in several festivals, farmer markets, and other large-scale outreach events happening across the county. The VEO team has also conducted outreach to all the Fulton County Libraries and will host VEO sessions in each library in preparation for the 2022 election cycle.

The VEO team will continue to contact schools, communities, non-profit organizations, and government officials regarding scheduling future events. We are developing ongoing outreach opportunities with various groups to strengthen our impact in the community. The VEO team will also continue working with external affairs to showcase the excellent outreach work across the county.
