

#### BLACK HISTORY MONTH







Hello, Fulton County. As I begin my second term as your District Attorney, I want to take a moment to reflect on the past four years and share my excitement for the years ahead. I ran for DA in 2020 because I saw an opportunity to both protect our neighborhoods and reform our criminal justice system—making it fairer, more transparent and focused on reducing crime by changing lives rather than just seeking punishment. But, as with most things in life, it's been a challenging journey. I started my first term during the height of a global pandemic, which created significant hurdles in the justice system. Despite these challenges, the dedicated team in this office worked relentlessly to reduce a massive backlog, cutting down nine years' worth of unindicted cases from 2014 to 2022. This isn't just about numbers; it's about the almost 49,570 cases over a 9 year period where we've brought justice to victims, dismissed charges to help individuals move forward, and offered second chances through our pre-indictment diversion program, allowing defendants to avoid the lasting consequences of an indictment.

I campaigned for and delivered Georgia's first Pre-Indictment Diversion Program in Fulton County. This program helps eligible defendants avoid indictment through restitution, community service, and life skills classes. It also assists those with criminal records in getting their records restricted to improve access to employment and housing. Since October 2021, this program has enrolled 765 participants, saving taxpayers a whopping \$17.87 million. It has collected over \$235,000 in restitution, completed over 15,500 hours of community service and provided over 5,600 hours of behavioral therapy to reduce recidivism.


Our Reach mentorship program has grown to 20 middle and high schools across Fulton County, serving around 800 students with resources and training to help steer them away from crime. We've also signed a historic agreement with Atlanta Tech to expand opportunities for young people in Fulton. Through initiatives like backpack and toy drives, coat giveaways, and record restriction programs, we've taken a proactive approach to engage with the community, showing that the services we provide go so much beyond just trials and plea hearings.


This office has achieved significant success in the courtroom, securing justice for victims of the most heinous crimes. We've strengthened our team of prosecutors and investigators to target violent gang leaders and members, leading to multiple gang and RICO indictments and convictions for violent crimes across the county. We are also holding sexual predators accountable. Our Sexual Assault Kit Initiative Unit has secured convictions in cases from rape kits that sat in storage for decades. Our Special Victims Division, which handles felony cases involving women, children, and the elderly, boasts an impressive 90% conviction rate. The Major Crimes Division, responsible for handling most murder cases, has been achieving over a 90% conviction rate. Under my administration, the Conviction Integrity Unit has evolved; it no longer only examines the fairness of convictions but now also reviews sentences, recognizing that injustice can sometimes stem from unduly harsh penalties imposed on guilty defendants. We've made decisions—sometimes tough ones—on cases involving police conduct, all with the goal of building trust in policing by holding bad actors accountable. When I took office, there was a backlog of over 100 cases involving police conduct. By the end of 2023, we had resolved that backlog, making charging decisions on every single case. As a result, we charged more officers than almost any other DA's office in the nation. Ending this backlog brought dignity to both the civilians affected and the officers under investigation by ensuring their cases were no longer stuck in limbo.

While we're heading in the right direction, there's still so much more to accomplish. One of my top priorities is the creation of a Domestic Violence Resource Center—a one-stop shop for victims of domestic violence. This center would provide essentials like food and clothing, assistance with obtaining proper identification, and potentially even a dedicated domestic violence court with judges specifically trained to handle these sensitive cases. We're forming a Human Trafficking Task Force to centralize cases in Fulton County, streamline resources across jurisdictions, and train law enforcement to spot the signs of trafficking. We must expand our Reach mentorship programs to more schools, equipping our kids with the tools to succeed in the real world.

For all its challenges, being District Attorney of Fulton County, Georgia is an honor of a lifetime. I hope you have found this video informative, and I'm excited to work with you toward a Fulton County that is a safer, more just place for everyone.

#### What to say when your Friend/Coworker is Grieving

People always say that death is a part of life. It is a very true statement with a very profound meaning but may be taken casually only when it does not pertain to you. In MCD we deal daily with tragic deaths and many times look at it in a very fragmented dissociated manner. But when death touches those close to us, it hits differently, whether that be for a friend or a coworker. As an advocate with more years of experience than I care to reveal, I feel I have all the words and expressions that professional training has instilled in me, however even someone like me can be ineffective when it comes to consoling a personal friend when death comes to their door. Additionally working in this field does not make us immune to tragedy. Some of us may be experiencing trauma at different levels and may share what you are going through with those close to you. I know I am not the only one, so in this article I'd like to talk about what are some of the things you can say when you are in a position that requires you to exercise sympathy and empathy. Here are some "dos" and "don'ts" for what to say:

- 1. First, it's important to approach the situation with sensitivity and compassion. Start with a simple expression of condolence, such as "I'm so sorry for your loss" or "My heart goes out to you during this difficult time."
- 2. Recognize the difficulty of the situation. You might say, "I can't imagine how hard this must be for you."
- 3. If you knew the deceased, sharing a fond memory can be comforting. For instance, "I remember when you and your dad did (something positive); they brought so much joy to those around them."
- 4. Let them know you are there for them. You can say, "If you need someone to talk to, I'm here for you," or "Please let me know if there's anything I can do to help."
- 5. Speak from the heart. Authenticity resonates more than rehearsed phrases. In the same way, be mindful of cliches. Steer clear of phrases that might seem dismissive, such as "They're in a better place" or "Everything happens for a reason."
- 6. After the initial conversation, check in on them later. A simple message or call can show that you care and are thinking of them.
- 7. Everyone grieves differently. Be understanding if they need space or don't want to talk. At the same time, know your friend and/or coworker and share with others who may not know what they are going through.
- 8. Finally, listen. Sometimes, the best support is simply being there to listen if they want to talk about their feelings or memories of the deceased.
- Remember, the goal is to offer comfort and support, so a kind and thoughtful approach will always be appreciated.

#### Dealing with Motion to Bifurcate Trial and Sever Possession of Firearm by Convicted Felon Charges

In certain cases, the Defendant can file a motion to sever charges in the indictment that they deem to be too prejudicial to remain on the indictment in conjunction with the other enumerated offenses in said indictment. This is not uncommon in cases involving the charge of "Possession of a Firearm by a Convicted Felon." The rationale here is that there is an inherent prejudicial effect in the charge since the allegation is that the Defendant is a convicted felon and thus, the jury may decisions based on his "bad character" as opposed to the evidence supporting the indictment in the case. This will obviously be a moot point if it is the only charge in the indictment against the Defendant, but it is a consideration the court may have to make if there are other counts alleging different offenses. In certain cases, the Court may be required to sever the charge from the remaining counts in the indictment and essentially hold a bifurcated trial. In those cases, the court will hold a trial on the other charges, a jury will render a verdict, and subsequent to that, evidence will be presented as to the defendant's convicted felon status so that the jury can decide if the defendant is guilty of being in possession of a firearm as a convicted felon.

In cases involving a possession of a firearm by convicted felon charge that also serves as the predicate offense for another charge, case law is abundantly clear that a motion to sever the charge and bifurcate the trial in such a case should be denied. Cooks v. State, 299 Ga. 787 (2016) (motion to bifurcate a possession of firearm by convicted felon charge where it serves as a predicate offense for Felony Murder should be denied); see also Lang v. State, 344 Ga. App. 623 (2018) (Trial court did not commit error by denying motion to bifurcate in gang case where the possession of a firearm by a convicted felon charge was material to the criminal gang activity count as it was the underlying felony for that count). However, if the Defendant's status as a convicted felon is not material or related to any other charge on the indictment save for the charge involving possession of a firearm by a convicted felony, the Georgia Supreme Court has held that a trial court shall bifurcate the trial so that the jury will hear the evidence on the more serious charges and render a verdict on those before commencing with the second phase of the trial and hearing evidence of the Defendant's status as a convicted felon. Vann v. State, 266 Ga. App. 238 (2004). An argument could be made if the Defendant's status as a convicted felon, albeit unrelated to other counts in the indictment, could be admissible in the State's case-in-chief if it is part of the proof required for Rule 404(b) evidence.


#### HATE CRIME LIVE CONFERENCE

On Friday, October 11th, District Attorney Fani Willis, Atlanta Police Department Chief Darin Schierbaum, City of Atlanta's Director of LGBTQ+ Affairs Malik Brown, and members of the District Attorney's LGBTQ+ Advisory Committee held a live press conference to discuss a recent hate crime investigation in Atlanta.

That morning, the Fulton County District Attorney's Office charged Ralph George Drabic with one count of criminal trespassing and one count of criminal damage to property in the second degree. The defendant allegedly vandalized property belonging to vendors and participants at the United States' first-ever pride event dedicated to Black LGBTQ+ individuals worldwide, the '2024 Global Black Pride Celebration.'

"If anything is done to violate the people who come here to celebrate rights, we are going to use the full extent of the law to prosecute them," said DA Fani T. Willis, as Atlanta Pride began that weekend. We are proud to support our community's vibrant LGBTQ+ members!

I hope this letter finds you well, and that you had a great holiday season, with hopefully, a little time to relax. Happy new year.




