

# Welcome to Benefits Open Enrollment!

It's that time of the year again! Time to take a break from your busy schedule and review your County benefit options. Enrollment for medical/prescription drugs, dental, vision and life/AD&D insurance coverage will be **September 25 – October 13, 2023**.

### **Enrollment Is Required!**

- Online enrollment is mandatory through the County's Employee Self Service (ESS) system: https://bit.ly/34mcmev
- Enroll by **October 13, 2023**; otherwise, you and your current dependents will automatically be enrolled in the Kaiser HMO Plan for all of 2024. And, you **won't** have dental or vision coverage!
- **If you currently waive medical coverage** but you're enrolled in the dental and vision plans, you must enroll through ESS to keep these plans.
- If you currently waive medical, dental and vision coverage, your coverage will continue to be waived for 2024 if you don't enroll through the ESS system.
- **To avoid a \$50 surcharge,** you must complete the *Tobacco-Use Attestation* in ESS by May 31, 2024.

## **Changes You Can Make**

During Open Enrollment, you can change your coverage for the plan year that starts January 1, 2024, including electing coverage you don't currently have, declining coverage you have now, or changing your coverage tier (e.g., moving from Employee to Employee + 1 for medical coverage). After Open Enrollment, you can't change your 2024 coverage during the year unless you have an IRSqualified life event (e.g., marriage, divorce, birth/adoption of a child).

**Important!** Please ensure you have your 10-digit employee ID number to access ESS.

## **2024 Health Care Plans and Premium Changes**

## For 2024, you have the same four medical plan options:

- Anthem HSA Plan: 1.7% premium increase
  - » In-network deductible increasing to \$1,800 single
  - » In-network deductible increasing to \$3,600 family
  - » Out-of-pocket maximum increasing to \$3,600 single
  - » Out-of-pocket maximum increasing to \$7,200 family
- Anthem POS Plan: 1.7% premium increase
- Anthem HMO Plan: 1.7% premium increase
- Kaiser HMO Plan: 6% premium increase

#### You also have two dental plan options:

- Aetna Dental PPO Plan: 2.7% premium increase
- Aetna Dental HMO Plan: 4% premium increase

#### You have one vision plan option:

• EyeMed Vision PPO Plan: 7.5% premium decrease

#### You have several life insurance options:

- MetLife Basic Life and AD&D Insurance: No changes
- MetLife Supplemental Life Insurance:\* No changes
- MetLife Dependent Life Insurance: No changes

\*If you are currently enrolled in supplemental life insurance, you may increase your coverage by \$25,000 without having to complete a medical questionnaire.

If you choose to enroll in supplemental life insurance and are not currently enrolled, your enrollment will be subject to approval after you complete a medical questionnaire (which MetLife will send to you after the close of Open Enrollment).

### **2024 Voluntary Benefits**

Voluntary benefit offerings will remain the same for the 2024 plan year.
